COMMISSION ANNOUNCEMENTS

CHAIRMAN LEVITT TO SPEAK AT LUNCHEON HOSTED BY WOMEN IN HOUSING AND FINANCE, INC.

SEC Chairman Arthur Levitt will speak at a luncheon hosted by Women in Housing and Finance, Inc. on Wednesday, January 21, 1998, at 1:00 p.m. at the Hyatt Regency Washington on Capitol Hill, 400 New Jersey Avenue, N.W. He will address the impact of technology on the securities markets and the SEC's regulatory framework.

ENFORCEMENT PROCEEDINGS

ROBERT WILSON SENTENCED

On January 12, Stephen V. Wilson, United States District Judge (C.D. Ca.) sentenced Robert C. Wilson (Wilson) to a federal prison term of 57 months on his guilty plea to charges in Florida and 46 months on his plea to charges in California. Wilson, a resident of Florida, entered the pleas in the U.S. District Courts for the Middle District of Florida and for the Central District of California. In Florida Wilson was charged with conspiracy to commit wire fraud in connection with the purchase of treasury securities. In California Wilson was charged with wire fraud and tax evasion in connection with an advance-fee payment scheme [U.S. v. Robert C. Wilson, Nos. 97-189-CR-T-99, E, M.D. Florida and CR97-178, C.D. Ca.].

Wilson and others were named as defendants in a parallel civil injunctive action brought by the Commission on December 20, 1995. The Commission's complaint alleges that a number of investors were defrauded by Wilson, Gary F. Long, Samuel L. Boyd and Debenture Guaranty Corp. in a scheme in which investors were solicited to invest in U.S. Treasury securities, which purportedly would be traded using a proprietary method that would produce unusually high yields. According to the complaint, investors' funds were not, in fact, being invested in any high yield investment program but were being misappropriated after a small portion of the funds was used to purchase securities on margin. The Commission's litigation against

INVESTMENT COMPANY ACT RELEASES

SIERRA VARIABLE TRUST, ET AL.

An order has been issued pursuant to Section 17(b) of the Investment Company Act exempting The Sierra Variable Trust (Trust), American General Life Insurance Company and American General Life Insurance Company Separate Account D (Separate Account) from the provisions of Section 17(a) of the Act to the extent necessary to permit the merger of the Trust's Short Term Global Government Fund into the Trust's Short Term High Quality Bond Fund and the combination of corresponding sub-accounts of the Separate Account investing therein. (Rel. IC-23001 - January 15)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the Philadelphia Stock Exchange (SR-Phlx-97-23) to provide double-up/double-down automatic price improvement and manual price protection to customer orders under certain circumstances. (Rel. 34-39548)

The Commission approved a proposal (SR-Phlx-96-38) filed by the Philadelphia Stock Exchange relating to the listing of flexible exchange-traded equity and index options. Publication of the approval order is expected in the Federal Register during the week of January 19. (Rel. 34-39549)

PROPOSED RULE CHANGE

The Philadelphia Stock Exchange filed a proposed rule change (SR-Phlx-97-55) that would amend Phlx Rule 1014(h) to establish an enhanced parity split pilot program for foreign currency option specialists effective until December 31, 1998. Publication of the

proposal is expected in the Federal Register during the week of January 19. (Rel. 34-39552)
