RULES AND RELATED MATTERS

PROPOSAL OF REGISTRATION FORM FOR VARIABLE LIFE INSURANCE POLICIES

The Commission has issued a release proposing for public comment new Form N-6 for the registration of variable life insurance policies. Form N-6 would, for the first time, provide a form specifically tailored for variable life insurance to be used for registration under the Investment Company Act and the Securities Act of 1933. The proposed form would focus prospectus disclosure on essential information that would assist an investor in deciding whether to invest in a particular variable life insurance policy. Proposed Form N-6 also would minimize prospectus disclosure about technical and legal matters and improve disclosure of fees and charges. (Rel. Nos. 33-7514; IC-23066; File No. S7-9-98)

ENFORCEMENT PROCEEDINGS

LAZAR FREDERICK & COMPANY AND BETTY ANN RUBIN ORDERED TO PAY DISGORGEMENT AND PREJUDGMENT INTEREST

On March 5, the United States District Court for the Central District of California entered a Final Judgment of Disgorgement against Betty Ann Rubin and Lazar Frederick & Company. The Court ordered Lazar, a broker-dealer, to pay \$6,990,650.25 in disgorgement and \$945,340.07 in prejudgment interest, totalling \$7,935,990.32. The Court also ordered Rubin, Lazar's president, to pay \$309,040.40 in disgorgement and \$37,370.52 in prejudgment interest, totalling \$346,410.92. Lazar and Rubin previously consented, without admitting or denying the Commission's allegations, to a permanent injunction from violating the registration and antifraud provisions of the securities laws.

The Commission's complaint alleged that Rubin, Lazar, and several co-defendants fraudulently offered and sold oil and gas limited partnerships from May 1993 through December 1995 through general solicitation. The complaint further alleged that Lazar sales agents misrepresented that the partnerships had paid investors between 10%

to 12% annually from partnership oil and gas revenue. The fraudulent Ponzi-like scheme raised more than \$34,934,000 from over 1,500 investors, many of whom were elderly. HOLDING COMPANY ACT RELEASES

ENTERGY LOUISIANA, INC.

An order has been issued authorizing Entergy Louisiana, Inc., an electric public-utility subsidiary company of Entergy Corporation, a registered holding company, to issue and sell through December 31, 2002 one or more new series of securities. These securities include first mortgage bonds and debentures, up to a combined aggregate outstanding principal amount of \$600 million. In addition, these securities include preferred stock, either \$25 or \$100 par value, and/or interests in a special purpose limited partnership or a statutory business trust, up to a combined aggregate outstanding principal amount of \$260 million. These securities also include collateral bonds, up to an aggregate outstanding principal amount of \$455 million. (Rel. 35-26839)

A proposed rule change (SR-Phlx-98-11) filed by the Philadelphia Stock Exchange to amend its examination fees to pass through costs has become effective immediately. Publication of the proposal is expected in the Federal Register during the week of March 16. (Rel. 34-39744)
