COMMISSION ANNOUNCEMENTS

SEC TO HOST SMALL BUSINESS TOWN HALL MEETING IN CLEVELAND, OHIO

The Commission announced that a small business town hall meeting will be held at 8:00 a.m. on Wednesday, October 28, 1998, at the Sheraton Cleveland City Centre Hotel at 777 St. Clair Avenue, Cleveland, Ohio. The small business town hall meetings, which are being conducted throughout the United States, convey basic information to small businesses about fundamental requirements that must be addressed when these businesses wish to raise capital through the public sale of securities. In addition, the Commission hopes to learn more about the concerns and problems facing small businesses in raising capital so that programs can be designed to meet their needs, consistent with the protection of investors.

Brian J. Lane, Director of the Division of Corporation Finance, will be the featured speaker of the Cleveland Small Business Town Hall Meeting. Other speakers include Elmar Koeberer, Deputy District Director for the U.S. Small Business Administration, Thomas E. Geyer, Commissioner, Division of Securities for the State of Ohio, and Teresa Kraus of the ACE-NET program at Enterprise Development, Inc., Case Western University. A question and answer period will follow the presentations.

FEE RATE ADVISORY

The continuing resolution (CR) the Securities and Exchange Commission has been funded under since October 1, 1998, has been extended until midnight Wednesday, October 14. At this time we cannot be certain what the fee rate will be for filings on Thursday, October 15. The three possibilities are:

- 1) If the CR is extended beyond Wednesday night, the fee rate on filings made pursuant to Section 6(b) of the Securities Act of 1933 will continue at the current rate of \$295 per \$1,000,000. This fee should be applied pro rata to amounts less than \$1,000,000 and

should be calculated by multiplying the aggregate offering amount by .000295.

- 2) If the CR is not extended and there is a funding gap, the fee rate on filings made pursuant to Section 6(b) of the Securities Act of 1933 will continue at the current rate of \$295 per \$1,000,000. This fee should be applied pro rata to amounts less than \$1,000,000 and should be calculated by multiplying the aggregate offering amount by .000295.
- 3) If the pending appropriations bill is enacted, the fee rate will decrease to \$278 per \$1,000,000. This rate also must be applied pro rata to amounts less than \$1,000,000. The fee should be calculated by multiplying the aggregate offering amount by .000278.

The Commission will issue further notices as appropriate to keep filers and registrants informed of developments affecting the section 6(b) fee rate. INVESTMENT COMPANY ACT RELEASES

CRABBE HUSON FUNDS, ET AL.

An order has been issued on an application filed by Crabbe Huson Funds, et al. under Section 6(c) of the Investment Company Act for an exemption from Section 15(a) of the Act. The order permits the implementation, without prior shareholder approval, of new investment advisory agreements (New Agreements) for a period of up to 120 days following the later of the date of acquisition of the assets of The Crabbe Huson Group, Inc. by LFC Acquisition Corp. (New Advisor) or the date on which the requested order is issued (but in no event later than February 28, 1999) (Interim Period). The order also permits the New Advisor to receive all fees earned under the New Agreements during the Interim Period following shareholder approval. (Rel. IC-23483 - October 9)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-NYSE-98-16) filed by the New York Stock Exchange that amends NYSE Rule 431, "Margin Requirements," to apply the maintenance margin requirements of NYSE Rule 431 to good faith accounts and to provide that the proprietary accounts of introducing broker-dealers that are "exempted borrowers"

under Regulation T will continue to be subject to NYSE Rule 431(e)(6). Publication of the order is expected in the Federal Register during the week of October 12. (Rel. 34-40529)

The Commission approved a proposed rule change (SR-PHLX-98-18) submitted by the Philadelphia Stock Exchange relating to Auto-X Contra Party Participation (Wheel). Publication of the order is expected in the Federal Register during the week of October 12. (Rel. 34-40530)
