ENFORCEMENT PROCEEDINGS

THOMAS O'CONNELL SETTLES PREVIOUSLY INSTITUTED ADMINISTRATIVE PROCEEDINGS

The Commission has accepted a settlement from Thomas B. O'Connell, a former investment adviser, concerning previously instituted administrative proceedings involving violations of the federal securities laws and misappropriation of funds.

In the settlement offer, O'Connell agreed to the issuance of an Order by the Commission Making Findings, Imposing Remedial Sanctions, and Imposing a Cease and Desist Order. The Commission finds, and O'Connell admits, that: (a) O'Connell misappropriated approximately \$11 million in proceeds from sales of unregistered limited partnership interests to investors, and (b) between 1989 through 1995, O'Connell falsely told investors in the limited partnerships that the partnerships were earning substantial returns when, in fact, the partnerships were losing money. O'Connell pleaded guilty to criminal charges relating to the scheme and was subsequently sentenced to 52 months in prison and ordered to pay \$11 million in restitution. He is currently serving his sentence. The Order permanently bars O'Connell from association with any broker, dealer, investment company, investment adviser, or municipal securities dealer and directs him to cease and desist from violating relevant provisions of the securities laws. HOLDING COMPANY ACT RELEASES

GPU, INC.

A notice has been issued giving interested persons until November 3, 1998, to request a hearing on a proposal by GPU, Inc., a registered holding company, to distribute rights regarding its common stock under a stockholder rights plan. (Rel. 34-26926)

AMERICAN ELECTRIC POWER CO., INC., ET AL.

A notice has been issued giving interested persons until November 3, 1998, to request a hearing on a proposal by American Electric Power Company, Inc. (AEP), a registered holding company, American Electric

Power Service Corporation, a nonutility subsidiary of AEP, eight electric utility subsidiary companies, Appalachian Power Company, Columbus Southern Power Company, Indiana Michigan Power Company, Kentucky Power Company, Ohio Power Company, AEP Generating Company, Kingsport Power Company, Wheeling Power Company (collectively Applicants), and AEP Energy Services, Inc., (AEP Energy) an energy-related subsidiary of AEP. Applicants request authority, through December 31, 2002, to: (1) extend the period of authorization by which AEP may guarantee the debt and other obligations (Guarantee Authority) of certain nonutility subsidiaries (New Subsidiaries); and (2) increase the Guarantee Authority of debt of New Subsidiaries from \$50 million up to \$100 million. In addition, AEP and the New Subsidiaries propose to broker and market energy commodities at wholesale and retail in Canada. (Rel. 34-26926)

COLUMBIA ENERGY GROUP, ET AL.

A notice has been issued giving interested persons until November 3, 1998, to request a hearing on a proposal by Columbia Energy Group (Columbia), a registered holding company, and its nonutility subsidiaries to acquire entities engaged in the exploration, development, production, manufacture, storage, transportation or supply of natural gas or synthetic gas within the United States and for these entities to receive an exemption from the Act under Rule 16 under the Act. In addition, Columbia's nonutility subsidiaries propose to amend their certificates of incorporation to change the par value of equity securities directly or indirectly held by Columbia, and to declare and pay dividends of capital to the extent permitted by state law. MONTAUP ELECTRIC CO., ET AL.

A notice has been issued giving interested persons until November 3, 1998, to request a hearing on a proposal by Montaup Electric Company and Eastern Edison Company, each an electric utility subsidiary company of Eastern Utilities Associates, to redeem or repurchase their debt or capital stock held by affiliates and to pay dividends out of capital and unearned surplus.
