INVESTMENT COMPANY ACT RELEASES

AETNA VARIABLE FUND, ET AL.

A notice has been issued giving interested persons until December 18, 1998, to request a hearing on an application filed by Aetna Variable Fund, Aetna Income Shares, Aetna Variable Encore Fund, Aetna Balanced VP, Inc., Aetna Generation Portfolios, Inc. Aetna Variable Portfolios, Inc., Aetna Get Fund, Portfolio Partners, Inc. (each a Fund), Aetna Life Insurance and Annuity Company (ALIAC), and Aeltus Investment Management, Inc. (Aeltus) (collectively, the Applicants). Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder to the extent necessary to permit shares of any current or future series of each Fund and shares of any other investment company that is offered as a funding medium for insurance products and for which ALIAC, Aeltus, or any of their affiliates, may now or in the future serve as investment adviser, principal underwriter or administrator, to be offered and sold to, and held by (1) variable annuity and variable life insurance separate accounts of both affiliated and unaffiliated life insurance companies, (2) qualified pension and retirement plans outside of the separate account context, and (3) the investment adviser of any Fund or any of the Adviser's affiliates. RANSON UNIT INVESTMENT TRUSTS, ET AL.

An order has been issued on an application filed by Ranson Unit Investment Trusts (Trust), et al. for an exemption from Sections 12(d)(3) and 17(a) of the Investment Company Act. The order permits: (a) certain series of the Trust to invest up to 10.5% and certain other series of the Trust to invest up to 20.5% of their respective total assets in securities of issuers that derived more than 15% percent of their gross revenues in their most recent fiscal year from securities related activities; and (b) a terminating series of the Trust to sell portfolio securities to a new series of the Trust. (Rel. IC-23546; International Series Rel. 1172 - November 24)

SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-98-18) to require that its participants successfully complete a Year 2000 validation test. The Commission approved the proposed rule change on an accelerated basis. Publication of the proposal is expected in the Federal Register during the week of November 23. (Rel. 34-40696)

PARTIAL ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted partial accelerated approval to a proposed rule change filed by the New York Stock Exchange (SR-NYSE-98-40) to implement a three-month pilot program to amend Paragraph 902.02 of the Exchange's Listed Company Manual. (Rel. 34-40698)

APPROVAL OF PROPOSED AMENDMENT

The Commission approved a proposed rule change filed by the Options Price Reporting Authority (SR-OPRA-98-1) to add a new Rider to OPRA's Vendor Agreement that would permit OPRA's vendors to utilize electronic contracts with certain categories of Internet or other on-line customers. PROPOSED RULE CHANGE

The MBS Clearing Corporation filed a proposed rule change (SR-MBSCC-98-03) to amend MBSCC's by-laws to increase the number of directors on its board from thirteen to fifteen. Publication of the proposal is expected in the Federal Register during the week of November 23. (Rel. 34-40702)

DELISTING GRANTED

An order has been issued granting the application of the Boston Stock Exchange to strike from listing and registration Seventh Generation, Inc., Common Stock, \$.000333 Par Value. (Rel. 34-40703)

WITHDRAWAL GRANTED

An order has been issued granting the application of Real Goods Trading Corporation to withdraw its Common Stock, No Par Value, from listing and registration on the Pacific Exchange. (Rel. 34-40704)
