

**NSA/CSS EVALUATED PRODUCTS LIST  
for  
OPTICAL MEDIA DESTRUCTION DEVICES**

This Evaluated Products List (EPL) contains a listing of destruction devices that have been evaluated by the National Security Agency (NSA) or its designee and meets the performance requirements of NSA/CSS Specification 04-02, Optical Media Destruction Devices and NSA/CSS Specification 02-01, High Security Crosscut Paper Shredders for machines with dual media destruction capability. Inclusion of a product in the EPL is not an endorsement by NSA or the U.S. Government.

The EPL provides the device name, distributor, and sales/marketing contacts for each destruction device evaluated for sanitization of Top Secret media. Models listed have successfully passed evaluation for the security and performance requirements of devices designed for the destruction of optical media (CDs and DVDs). The one hour duration performance is a calculated rate by using only 200 optical disks of the appropriate media (CD and or DVD). The EPL is organized by category of destruction technique employed in the device (cutting, dual media cutting, milling, grinding, and knurling) and alphabetically by distributor name.

**The Destruction Evaluations and Guidance Branch of the NSA has determined that disintegrators currently listed on the NSA/CSS 02-02 Evaluated Products List (EPL) also provide adequate security for the destruction of optical media (CDs and DVDs) in accordance with NSA/CSS 04-02, Optical Media Destruction Devices. It is recommended that paper be mixed with the optical media during destruction by means of disintegration. Please contact the manufacturer to determine if a specific product is mechanically suited for optical media destruction.**

The EPL shall be updated on an as-needed basis (as new models are successfully evaluated). Users are encouraged to contact the disintegrator manufacturers /distributors for assistance in selecting unit(s) best suited to their requirements, and to determine if additional disintegrator units have been added to the EPL in the interim.

The procedures for administration and distribution of the EPL are subject to change without notice. Inquiries from U.S. Government users should be forwarded through designated support channels to the NSA Information Assurance Directorate and the Center for Storage Device Sanitization Research. All other inquiries should be directed to the NSA Public Affairs Office.
