ENFORCEMENT PROCEEDINGS

CRAIG MEDOFF BARRED AND REGISTRATION OF HERCULES CAPITAL, INC. REVOKED

On January 6, the Commission issued an Order Instituting Public Administrative Proceedings Pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act), Making Findings and Imposing Remedial Sanctions against Hercules Capital, Inc. (Hercules), a registered broker-dealer located in New York, New York and Craig Medoff (Medoff), Hercules' president. The Commission's Order bars Medoff from associating with any broker, dealer, investment adviser, investment company or municipal securities dealer, and revokes Hercules' registration with the Commission as a broker-dealer.

The Commission simultaneously accepted an Offer of Settlement from Medoff and Hercules in which each consented, without admitting or denying the Commission's findings, except for the finding that, on September 7, 1993, both were permanently enjoined on consent by the United States District Court for the Southern District of New York from future violations of Section 17(a) of the Securities Act of 1933 (Securities Act) and Exchange Act Section 10(b) and Rule 10b-5 thereunder (SEC v. Medoff, 93 Civ. 5573, LLS, SDNY).

The Commission's complaint in the injunctive action alleged, among other things, that from at least July through August 1993, Medoff and Hercules violated Securities Act Section 17(a) and Exchange Act Section 10(b) and Rule 10b-5 by offering and selling Air Tech Industries, Inc. (Air Tech) stock to the public by means of materially false and misleading statements and statements with no reasonable basis contained in an offering circular entitled "Prospectus," dated November 20, 1992, a one page document purporting to be Air Tech's sales literature, but apparently created by Medoff and Hercules, and a cover letter on Hercules' stationery, signed by Medoff. INVESTMENT COMPANY ACT RELEASES

UNITED FUNDS, INC. ET AL.

An order has been issued on an application filed by United Funds, Inc., et al. under Section 6(c) of the Investment Company Act for an exemption from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits applicants to offer an unlimited number of classes, add a conversion feature, and assess, and, under certain circumstances waive, a contingent deferred sales charge (CDSC) on redemptions of shares. The order supersedes a prior order that permits certain of the investment company applicants to assess and, under certain circumstances, waive a CDSC on redemptions of shares. (Rel. OFFITBANK VARIABLE INSURANCE FUND, INC., ET AL.

A notice has been issued giving interested persons until February 6 to request a hearing on an application filed by Offitbank Variable Insurance Fund, Inc. (Fund) and Offitbank (collectively, Applicants). Applicants request that the Commission issue an order under Section 6(c) of the Investment Company Act for exemptive relief from Sections 9(a), 13(a), 15(a) and 15(b) of the Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder. Applicants seek exemptive relief to the extent necessary to permit shares of any current or future investment series of the Fund to be sold to and held by the separate accounts funding variable annuity and variable life insurance contracts issued by certain affiliated and unaffiliated life insurance companies. HOLDING COMPANY ACT RELEASES

CINERGY CORP.

An order has been issued regarding a proposal by CINergy Corp. (CINergy), a registered holding company. CINergy requests authorization to issue and sell, from time to time through January 31, 1997, in an aggregate principal amount at any one time outstanding not to exceed \$375 million, unsecured short-term promissory notes to banks and other financial institutions, commercial paper to commercial paper dealers and financial institutions, and unsecured demand promissory notes to banks evidencing CINergy's reimbursement obligation in respect of letters of credit issued by such banks on CINergy's behalf. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the National Association of Securities (SR-NASD-94-70) to consolidate the Nasdaq Level 1 and Last Sale Information services and the corresponding subscriber charges. Publication of the proposal in the Federal Register is expected during the week of January 16. (Rel. 34-35217)

The Commission approved Amendment No. 2 to a Joint Industry Reporting Plan for Nasdaq/National Market securities traded on an exchange on an unlisted or listed basis, submitted by the National Association of Securities Dealers and the Boston, Chicago, and Philadelphia Stock Exchanges (File No. S7-24-89) to extend the effectiveness of the Commission's approval of the Plan and to extend certain exemptive relief granted by the Commission in conjunction with the Plan through August 12, 1995.
