COMMISSION ANNOUNCEMENTS

UPDATED EDGAR FILER MANUAL ADOPTED

The Commission today issued a release adopting an updated EDGAR Filer Manual, effective June 7, 1995, which reflects enhancements to the EDGAR system (Release No. 33-7169). In this update, new form types have been added in order to implement solutions to prospectus delivery issues arising in connection with the change to T+3 securities transaction settlement. The updated manual also contains some minor additional changes to reflect improvements requested by the filer community and SEC staff, such as the extension of the length of time that temporary passwords remain active. ENFORCEMENT PROCEEDINGS

TEMPORARY RESTRAINING ORDER ISSUED AS TO JOHN BENNETT, JR.

On May 18, the Honorable Anita B. Brody, United States District Judge for the Eastern District of Pennsylvania, issued an Order temporarily restraining John G. Bennett, Jr., the founder, chairman of the board and president of The Foundation for New Era Philanthropy, from violating the

registration and antifraud provisions of the federal securities laws. Judge Brody's Order also freezes Bennett's assets, except for living expenses and reasonable attorneys' fees, orders him to provide an accounting of his assets and prohibits the destruction of documents. The Order remains in effect until June 12, 1995, at which time Judge Brody will hold a hearing to determine whether to enter a preliminary injunction and grant other relief. [SEC v. John C. SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The National Securities Clearing Corporation filed a proposed rule change (SR-NSCC-95-05) to modify NSCC's procedures relating to the trade comparison service for debt securities by expanding the parameters for trade input and comparison of transactions in debt securities. Publication of the proposal is expected in the Federal Register during the week of May 22. (Rel. 34-35733)
