ENFORCEMENT PROCEEDINGS

CIVIL ACTION AGAINST JONATHAN MAYHEW

The Commission announced the filing of an action in the U.S. District Court for the District of Connecticut against Jonathan Mayhew for violations of Sections 10(b) and 14(e) of the Securities Exchange Act of 1934 and Rules 10b-5 and 14e-3 promulgated thereunder, seeking a permanent injunction, disgorgement of illegal trading profits, prejudgment interest, and a penalty under the Insider Trading Sanctions Act. The complaint alleges that, while in possession of material nonpublic information about merger discussions between Rorer Group, Inc. and Rhône-Poulenc S.A., Mayhew traded in the securities of Rorer and made over \$255,000 in illegal insider trading profits. The complaint alleges that Mayhew received a tip from an employee of a human resources consulting firm which had been retained by Rorer in connection with the confidential merger discussions. According to the complaint, the consulting firm employee informed Mayhew that a high level Rorer officer had disclosed to the consulting firm employee the material fact that Rorer was in serious merger discussions. Prior to the public announcement of the discussions by Rorer, Mayhew had accumulated a position of 9,500 shares of Rorer common stock and 100 call options, which he sold immediately following the public announcement. INVESTMENT COMPANY ACT RELEASES

MINNESOTA MUTUAL LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until September 2 to request a hearing on an application filed by Minnesota Mutual Life Insurance Company, Minnesota Mutual Variable Annuity Account (Variable

Account) and MIMLIC Sales Corporation (collectively, Applicants). The Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Variable Account in connection with the issuance and sale of certain variable annuity contracts. PRESIDENTIAL ASSOCIATES I LIMITED PARTNERSHIP, ET AL.

An order has been issued on an application filed by Presidential Associates I Limited Partnership (Partnership) and its managing general partner, Winthrop Financial Co., Inc., amending a prior order issued under Section 6(c) of the Investment Company Act. The prior order exempts the Partnership from all provision of the Act and permits the Partnership to invest in another partnership, Presidential Towers, Ltd. (Operating Partnership), that owns and operates residential apartments for moderate income persons. The amended order permits a new investor to invest in the Operating Partnership. (Rel. UNLISTED TRADING PRIVILEGES GRANTED

Orders have been issued granting the applications of four exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchange and are reported in the consolidated transaction reporting system. The exchanges and number of issues are: Chicago Stock Exchange - 18 issues (Rel. 34-34501); Boston Stock Exchange - 14 issues (Rel. 34-34502); Cincinnati Stock Exchange - 6 issues (Rel. 34-34504); and Philadelphia Stock Exchange - 23 issues (Rel. 34-34506).

DELISTING GRANTED

An order has been issued granting the application of the New York Stock Exchange to strike from listing and registration Kaufman and Broad Home Corporation, Special Common Stock, \$1.00 Par Value. (Rel. 34-34503)

TEMPORARY ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted temporary accelerated approval to a proposed rule change filed by the American Stock Exchange (SR-Amex-94-28) to extend for three months, until November 8, 1994, its pilot program for the execution of odd-lot market orders. (Rel. 34-34496)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE AND AMENDMENTS

The Commission approved on an accelerated basis a proposal (SR-Amex-94-20) by the American Stock Exchange to list and trade options on the Mexico Index (Index), a narrow-based, "modified" equal dollar weighted index comprised of ten Mexican stocks or American Depositary Receipts traded on the New York Stock Exchange, Amex or that are National Market securities traded through the National Association of Securities Dealers Automated Quotation system. Publication of the notice is expected in the Federal Register during the week of August 15. (Rel. 34-34500; International Series Rel. 697)
