COMMISSION ANNOUNCEMENTS

SCHAPIRO TASK FORCE REPORT RELEASED

Commissioner Mary L. Schapiro, head of the Commission's Task Force on Administrative Proceedings, announced the release of the Task Force's report, entitled "Fair and Efficient Administrative Proceedings." The report, the result of a comprehensive review of the Commission's adjudication program, focuses on the conduct of litigated enforcement actions and appeals of disciplinary proceedings by the National Association of Securities Dealers and securities exchanges. CIVIL PROCEEDINGS

COMMISSION AMENDS TOWERS COMPLAINT

On March 3, the Commission amended its complaint in the civil action against Towers Financial Corporation (Towers). Steven Hoffenberg, Mitchell Brater and Arthur J. Ferro, originally filed on February 8, 1993, to add five wholly-owned subsidiaries of Towers as additional defendants. The amended complaint also adds three relief defendants, two of which, New York Post Publishing Incorporated and New York Post Realty Incorporated are entities partially owned by Hoffenberg. The third relief defendant is New York Post Co., Inc. (Post), which publishes the New York Post. The amended complaint alleges that Towers, through its subsidiaries, fraudulently sold almost \$200 million of securities. The amended complaint further alleges that the three relief defendants received, are receiving, or will receive, funds from Hoffenberg and/or Towers in connection with the sale of the New York Post to Hoffenberg, which funds were obtained by Hoffenberg and/or Towers through the fraudulent sale of Towers' securities. PERMANENT INJUNCTION ENTERED AGAINST RANDAL FORMAN

The Commission announced that on March 3 Judge William J. Zloch of the U.S. District Court, Southern District of Florida, entered an Order of Permanent Injunction by consent against Randal C. Forman, a resident of Boca Raton, Florida, enjoining him from future violations of the antifraud provisions of the federal securities laws. Forman was the manager, head trader and 36 percent owner of the Florida branch office of Kettler & Company, formerly a broker-dealer based in Chicago, Illinois. The Commission will seek an Order requiring Forman to produce an accounting and to disgorge all ill-gotten gains.

The complaint, filed on September 22, 1992 alleges that in 1988 Kettler & Co. underwrote an initial public offering in Windy City Capital Corporation on a best-efforts, all-or-none basis. The Florida branch completed the offering in June and July 1988. From July 19 through July 29, 1988, the first nine days of secondary market trading in Windy City common stock, Forman engaged in a fraudulent scheme to manipulate the price of the stock and to charge secondary market customers excessive, undisclosed markups as high as 130 percent above the prevailing market price. INVESTMENT COMPANY ACT RELEASES

THE GALAXY VIP FUND, ET AL.

An order has been issued under Section 6(c) of the Investment Company Act exempting The Galaxy VIP Fund (VIP Fund), Fleet Investment Advisors, Inc., and certain life insurance companies and their separate accounts investing now or in the future in the VIP Fund (collectively, Applicants) from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder. The exemptions apply to the extent necessary to permit shares of any current or future series of the VIP Fund to be sold to and held by separate accounts funding variable annuity and variable life insurance contracts issued by both affiliated and unaffiliated life insurance companies. Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
