CIVIL PROCEEDINGS

CIVIL ACTION AGAINST MARVIN KATZ

The Commission announced that on April 20 the Honorable William M. Nickerson of the U.S. District Court for the District of Maryland enjoined Marvin H. Katz (Katz), by consent, from further violations of Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder, and ordered Katz to disgorge \$346,000 plus prejudgment interest in the amount of \$124,263. The court further ordered that payment of the disgorgement and prejudgment interest be deferred until after a determination of Katz' financial condition and ability to pay the specified amounts.

The Commission's complaint alleged that from approximately February 1988 through May 1992, Katz, the principal shareholder and president of Fidelity Land Development Corporation (Fidelity Land), engaged in a fraudulent scheme to raise approximately \$346,000 through the sale of promissory notes to 14 investors. According to the complaint, Katz represented that he would use the funds to finance selected real estate development projects proposed by Fidelity Land. However, according to the complaint, Katz used all or most of the money for personal expenses. [SEC v. Marvin H. Katz, USDC for the District of Maryland, Civil Action No. WN92-2584] (LR-13625)

INVESTMENT COMPANY ACT RELEASES

AMERICAN GENERAL EQUITY ACCUMULATION FUND, INC.

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-93-04) to establish a fee schedule for use of the interface with the National Securities Clearing Corporation's Networking service. The proposed rule change became effective upon filing with the Commission. Publication of the proposal is expected in the Federal Register during the week of April 26. (Rel. 34-32209)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved on an accelerated basis a proposed rule change (SR-PTC-93-01) filed by the Participants Trust Company to increase the number of directors on PTC's Board of Directors. Publication of the proposal is expected in the Federal Register during the week of May 3. (Rel. 34-32213)

APPROVAL ON A TEMPORARY BASIS OF PROPOSED RULE CHANGE

The Commission approved on a temporary basis, until April 30, 1994, a proposed rule change filed by the National Securities Clearing Corporation (SR-NSCC-93-3) that establishes a pilot program relating to the handling of physical securities and paper transactions for participants located in New York City. Publication of the proposal is expected in the Federal Register during the week of May 3. (Rel. 34-32221)
