CIVIL PROCEEDINGS

CIVIL ACTION AGAINST ALLAN MILEW

The Commission announced that on April 28, 1993 the U.S. District Court for the Central District of California entered a Final Judgment of Permanent Injunction against defendant Allan G. Milew. Milew, without admitting or denying the allegations in the complaint, consented to the issuance of a Final Judgment that permanently restrains and enjoins him from future violations of Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 promulgated thereunder, orders disgorgement in the amount of \$ 2,500 and imposes a two time ITSFEA civil penalty pursuant to Exchange Act Section 21A in the amount of \$5,000.

The Commission's complaint alleged that on April 20, 1992 Milew, then a director of Fontana First National Bank (Fontana), purchased 1,000 shares of Fontana common stock after learning material nonpublic information concerning the acquisition of Fontana by CVB Financial Corp. [SEC v. Allan G. Milew, Civil Action No. 93-2343, AAH, EEx, C.D. Cal.] (LR-13650)

INVESTMENT COMPANY ACT RELEASES

SHEARSON VIP SEPARATE ACCOUNT OF FIRST CAPITAL LIFE INSURANCE COMPANY - IN CONSERVATION

PREFERRED GROUP OF MUTUAL FUNDS

An order has been issued on an application filed by The Preferred Group of Mutual Funds (Trust) under Sections 6(c) and 17(b) of the Investment Company Act granting an exemption from Section 17(a) of the Act. The exemption applies to the extent necessary to permit each present or future series of the Trust to engage in principal transactions with securities dealers that may be deemed to be affiliated persons of affiliated persons of the series solely because of subadvisory relationships with one or more of applicant's other series. (Rel. IC-19490 - May 25)

LIBERTY ALL-STAR EQUITY FUND, ET AL.

A conditional order has been issued on an application filed by Liberty All-Star Equity Fund, et al. under Section 6(c) of the Investment Company Act granting a limited exemption from Section 15(a) of the Act. The order permits applicants to enter into new sub-advisory agreements incident to a change in sub-advisers or the addition of a sub-adviser and delay shareholder approval of such contracts until Liberty All-Star Equity Fund's annual meeting. (Rel. IC-19491 - May 25)

ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
