COMMISSION ANNOUNCEMENTS

PENNY STOCK RULES

Today, the Securities and Exchange Commission, National Association of Securities Dealers (NASD), New York Stock Exchange (NYSE) and 40 State Securities Commissions working through the North American Securities Administrators Association (NASAA) commenced a coordinated examination effort to determine whether broker-dealers are in compliance with the Commission's Penny Stock Rules (Securities Exchange Act Rules 15g-1 through 15g-6). The Penny Stock Rules, most of which became effective on January 1, 1993, impose enhanced disclosure and record-keeping requirements on broker-dealers purchasing from or selling to the public certain low-priced, non-NASDAQ, non-exchange listed securities (Penny Stocks). RULES AND RELATED MATTERS

RULE 3a-8 PROPOSED FOR COMMENT

The Commission is proposing for public comment Rule 3a-8 under the Investment Company Act. Certain research and development companies maintain large amounts of liquid assets in the form of securities to fund their operations. Rule 3a-8 would provide a nonexclusive safe harbor from investment company status for any research and development company that has held itself out and currently holds itself out as being primarily engaged in a noninvestment business, uses its capital to support its research and development activities, and makes investments that, taken as a whole, conserve capital and liquidity until it uses its funds in its primary business. PROPOSED RULE CHANGE

ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.

Below is a list of recent filings of Schedules 13D and 14D, which includes the following information: Column 1 - the company purchased (top), and the name of the purchaser; Column 2 - the type of security purchased; Column - 3 - the type of form filed; Column 4 - the date the transaction occurred; Column 5 - the current number of shares (in 000's) owned (top) and the current percent owned; Column 6 - the CUSIP number (top) and the percent owned; and Column 7 - the status of the filing, i.e., new, update or revision.
