SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Depository Trust Company filed with the Commission a proposed rule change that would establish a revised schedule of its fees, effective for services performed after February 28, 1991. Publication of the proposal is expected in the Federal Register during the week of February 18. (Rel. 34-28870)

PROPOSED RULE CHANGES

Proposed rule changes have been filed by the following under Rule 19b-4 of the Securities Exchange Act: National Securities Clearing Corporation (SR-NSCC-91-01) to provide for membership of Participants Trust Company in the Securities Clearing Group (Rel. 34-28872); and American Stock Exchange (SR-AMEX-90-16) to conform AMEX's post-trade processing rules with the requirements of AMEX's Intra-Day Comparison System (Rel. 34-28873). Publication of the proposals is expected in the Federal Register during the week of February 18.

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
