### CIVIL PROCEEDINGS

#### COMPLAINT NAMES PETER FRANZEN AND CARL STEINER

The Commission announced today that it filed a complaint in the U.S. District Court for the District of Columbia against Peter Franzen (Franzen) and Carl Steiner (Steiner) seeking to permanently enjoin them from further violations of Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 10b-5 thereunder. Steiner has agreed, without admitting or denying the allegations contained in the complaint, to consent to the entry of a Final Judgment of Permanent Injunction which enjoins him from future violations of Section 10(b) of the Exchange Act and Rule 10b-5 thereunder.

The complaint alleges that in connection with the acquisition by Steiner Optics International, Inc. (SOI) of Steiner Optik GmbH (SOG), a manufacturer and distributor of binoculars previously owned by Steiner, Franzen and Steiner engaged in a scheme to disguise the consideration paid by SOI to Steiner and caused SOI to issue a press release and promotional material in January 1989 and to file a Current Report on Form 8-K with the Commission in April 1989 that contained materially false and misleading statements and omitted material information about the acquisition of SOG and the change in control of SOI which violated Section 10(b) of the Exchange Act and Rule 10b-5 thereunder. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
