## TRADING SUSPENSIONS

### TEN-DAY SUSPENSION OF TRADING IN THE SECURITIES OF TEXSCAN CORPORATION

The Commission announced the ten-day suspension of trading in the securities of Texscan Corporation on the American Stock Exchange or otherwise for the period beginning at 9:30 a.m. (EST) on April 22, 1991, and terminating at 11:59 p.m. (EST) on May 3, 1991. The Commission suspended trading in the securities of Texscan Corporation in view of recent market activity in those securities that may be the result of manipulative conduct or other illegal activity. ## SELF-REGULATORY ORGANIZATIONS

### PROPOSED RULE CHANGES

Proposed rule changes have been filed under Rule 19b-4 of the Securities Exchange Act by the following: Stock Clearing Corporation of Philadelphia (SR-SCCP-91-01) relating to the establishment of a liability notice procedure for book-entry deliverable instruments with an exercise privilege (Rel. 34-29092); and National Association of Securities Dealers (SR-NASD-91-15) to amend the Resolution of the Board of Governors -- Notice to Membership and Press of Suspensions, Expulsions, Revocations and Monetary Sanctions Under Article V, Section 1 of the NASD's Rules of Fair Practice to conform with the current practices of the NASD with respect to the effectiveness and publicity of disciplinary sanctions (Rel. 34-29101). Publication of the proposals is expected in the Federal Register during the week of April 22.

### ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission has granted accelerated approval to proposed rule changes filed under Rule 19b-4 of the Securities Exchange Act by the following: Philadelphia Stock Exchange (SR-PHLX-91-18) to allow the PHLX to list long-term equity options that expire up to 39 months after the date they are listed (Rel. 34-29103); and Pacific Stock Exchange (SR-PSE-91-01) to allow floor-wide implementation of the automatic execution feature of the PSE's automated options trading system called POETS and to extend the POETS pilot program until July 31, 1992 (Rel. 34-29104). Publication of the orders is expected in the Federal Register during the week of April 22.

## APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted by the National Association of Securities Dealers (SR-NASD-91-10) to require that FOCUS Reports be filed electronically, not by paper filings. The rule change was submitted in conjunction with a new Plan For the Implementation of FOCUS Reports filed by the NASD pursuant to Securities Exchange Act Rule 17a-5(a)(4). (Rel. 34-29105)

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
