INVESTMENT COMPANY ACT RELEASES

PATHFINDER HERITAGE FUNDS

A notice has been issued giving interested persons until December 16 to request a hearing on an application filed by Pathfinder Heritage Funds for an order under Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. (Rel. IC-18412 - November 20)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The Chicago Board Options Exchange filed with the Commission under Rule 19b-4 a proposed rule change (SR-CBOE-91-39) which limits to 120 the number of days in which a respondent involved in a disciplinary proceeding may submit offers of settlement to the CBOE's Business Conduct Committee after a statement of charges has been served. The proposal also limits to two the number of offers which may be presented during that 120-day period. Publication of the proposal is expected in the Federal Register during the week of November 25. (Rel. 34-29959)

The Chicago Board Options Exchange filed with the Commission under Rule 19b-4 a proposed rule change (SR-CBOE-91-41) which would require each CBOE member to establish, maintain and enforce written policies and procedures reasonably designed to prevent the misuse of material, nonpublic information by such member or persons associated with that member. Publication of the proposal is expected in the Federal Register during the week of November 25. (Rel. 34-29967)

The American Stock Exchange filed a proposed rule change (SR-Amex-91-29) with the Commission under Rule 19b-4 to amend Amex Rules 131 and 154, on a permanent basis, to broaden a specialist's ability to represent percentage orders and generally to expand the types of percentage orders allowed to be effected on the Amex. Publication of the proposal is expected in the Federal Register during the week of November 25. (Rel. 34-29969)

The MBS Clearing Corporation filed a proposed rule change (SR-MBSCC-90-08) with the Commission under Rule 19b-4 that would revise the current standards by which it decides whether to approve an issuer of a letter of credit used for clearing fund purposes. MBSCC amended this proposal on August 19, 1991. Publication of the proposal is expected in the Federal Register during the week of November 25. (Rel. 34-29973)

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-91-57) with the Commission under Rule 19b-4. The proposal amends the NASD Code of Arbitration Procedure to improve the efficiency of its arbitration process. The proposed rule change is intended to allow for a single arbitrator in simplified cases where a counterclaim exceeds \$10,000, unless the parties demand a panel of three arbitrators. In the event that the amount in controversy exceeds \$30,000, a panel of three arbitrators would be appointed. Publication of the proposal is expected in the Federal Register during the week of November 25. (Rel. 34-29974)

APPROVAL OF PROPOSED RULE CHANGES

The Commission has approved a proposed rule change (SR-PSE-91-10) submitted by the Pacific Stock Exchange to require PSE market makers, floor brokers, specialists or other member organizations who enter into financial arrangements with any other PSE member to disclose to the Exchange the terms of such arrangements. Publication of the order is expected in the Federal Register during the week of November 25. (Rel. 34-29961)

APPROVAL OF PROPOSED BYLAW CHANGE

The Commission issued an order approving a proposed bylaw change filed by the Securities Investor Protection Corporation (SIPC-91-1) amending its bylaw relating to SIPC Fund assessments on SIPC members. (Rel. SIPA-157)

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
