## CIVIL PROCEEDINGS

### ACTION FILED AGAINST GAF CORPORATION AND JAMES T. SHERWIN

The Commission today filed a Complaint in the U.S. District Court for the District of Columbia seeking to enjoin GAF Corporation and James T. Sherwin, Vice Chairman of GAF, from violating or aiding and abetting violations of the antifraud, books and records, and beneficial ownership reporting provisions of the Securities Exchange Act. The Complaint also seeks to have GAF disgorge \$1,250,000, plus prejudgment interest. Defendants, without admitting or denying the Complaint's allegations, consented to entry of Final Judgments. GAF also agreed to disgorge \$1,250,000, plus prejudgment interest.

The Complaint alleges that on October 29, 1986, at Sherwin's request, Boyd Jefferies agreed to close the price of Union Carbide Corporation common stock at \$22 or higher and Sherwin guaranteed Jefferies against loss. At the time, GAF was negotiating to sell a large block of the stock. Jefferies & Co. bought Union Carbide stock on two days, thereby increasing the stock's price. Subsequently, Jefferies sold the stock at a loss and sent a false invoice to GAF to recover the loss. Sherwin authorized payment on the false invoice. [SEC v. GAF Corporation and James T. Sherwin, USDC DC, Civil Action No. 90-0527 (JHP)] (LR-12401; Rel. AAER-254).
