### CONSOLIDATED NATURAL GAS COMPANY

A notice has been issued giving interested persons until April 23 to request a hearing on a proposal by Consolidated Natural Gas Company to amend and restate its Certificate of Incorporation (Certificate) and make conforming amendments to its By-Laws subject to stockholder approval, to: (1) require written notice by a stockholder of a proposed nomination of a person for election to the board of directors (Board); (2) require the written consent of at least 75% of the stockholders in order for Consolidated to take certain actions without prior notice, a meeting or a vote; (3) increase the minimum stockholding percentage needed to request a mandatory call of a special stockholders' meeting; and (4) require the affirmative vote of either a two-thirds majority of continuing Board members and a majority of stockholders or a majority of the Board members and at least 75% of stockholders to recommend certain changes in the Certificate. Consolidated has been granted authorization to solicit proxies. (Rel. 35-25067)

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
