CIVIL PROCEEDINGS

RICHARD L. BURNS PERMANENTLY ENJOINED

The Los Angeles Regional Office announced that on February 20 the Hon. J. Lawrence Irving, U.S. District Judge for the Southern District of California, permanently enjoined Richard L. Burns, former Chairman and CEO of Nucorp Energy, Inc., from violations of the antifraud prohibitions against trading by persons interested in a distribution, and reporting provisions of the Securities Act of 1933 and Securities Exchange Act of 1934. The action followed a September 17, 1985 trial.

Judge Irving found, among other things, that a practice whereby Nucorp or its subsidiaries recognized sales revenue prior to the shipment of goods or receipt of payment for those goods was a fraud on investors, potential investors, creditors and anyone else who relied on Nucorp's false financial statements and that Burns knew of the practice and did nothing to stop it. Judge Irving further found that Burns induced purchases of Nucorp common stock by Nucorp subsidiary executives at a time when Nucorp was engaged in a distribution of common stock. Burns' co-defendant, David W. Watt, previously consented to an injunction. (SEC v. Richard L. Burns and David W. Watt, Civil No. 84-0454-JLI(M)(S.D.Cal.). (LR-11011)

INVESTMENT COMPANY ACT RELEASES

PENNSYLVANIA ELECTRIC COMPANY

SELF-REGULATORY ORGANIZATIONS

NOTICE OF PROPOSED RULE CHANGE

The Philadelphia Stock Exchange, Inc. filed a proposed rule change under Rule 19b-4 (SR-Phlx-86-1) to change the bid-ask differentials applicable to individual stock options and index options.

Publication of the proposal is expected to be made in the Federal Register during the week of March 4. (Rel. 34-22950)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted by the Chicago Board Options Exchange, Inc. (SR-CBOE-85-53) to allow the listing of series of Standard & Poor's 500 Index options that expire in up to five different months, with the longest-term series having eleven months to expiration upon listing. MUNICIPAL SECURITIES RULEMAKING BOARD PROPOSED RULE APPROVED

The Commission has approved a proposed rule submitted by the Municipal Securities Rulemaking Board (MSRB) pursuant to Section 19(b) of the Securities Exchange Act of 1934 and Rule 19b-4 thereunder that amends MSRB Rule G-12 on uniform practice to provide confirmation of the concession as a percentage of the bond's price in dealer transactions in zero coupon, compound interest, and multiplier securities. Notice of the rule change is expected to be published in Federal Register during the week of March 3. (Rel. 34-22954)

An order has been issued under the Trust Indenture Act of 1939 on application of Citicorp that the trusteeship of United States Trust Company of New York under four existing, previously qualified indentures, and a Pooling and Servicing Agreement dated as of November 1, 1985 under which certificates evidencing interests in a pool of mortgage loans have been issued, is not so likely to involve a material conflict of interest as to make it necessary to disqualify the United States Trust Company of New York as trustee.
