CIVIL PROCEEDINGS

PERMANENT INJUNCTION ENTERED AGAINST GEORGE W. RIDENOUR, JR.

The Atlanta Regional Office announced that on November 6 Judge Elsjane T. Roy, U.S. District Court for the Eastern District of Arkansas, issued a Final Judgment of Permanent Injunction against George W. Ridenour, Jr., former general counsel and director of the failed United American Bank in Knoxville, Tennessee (UABK). Ridenour consented to the permanent injunction, which prohibits future violations of the antifraud provisions of the securities laws, without admitting or denying the complaint's allegations. Defendant Jacob Butcher, former chairman of the board and chief executive officer of UABK, previously consented to a permanent injunction entered on January 3, 1985, and is now serving a 20-year sentence for bank fraud and other crimes.

The Commission alleged in its November 9, 1984 complaint that the defendants made misrepresentations and omitted to state material facts about, among other things, self-dealing and the financial condition of UABK in the sale of common stock. A Commission Motion for Summary Judgment is pending against the remaining defendant, Jesse Barr, who is serving an 18-year sentence for bank fraud and other crimes. (SEC v. Jacob F. Butcher, et al., EDAK, Western Division, Civil Action No. LR-C-84-942). (LR-10933)

TEMPORARY RESTRAINING ORDER ENTERED AGAINST WESTERN GOLD, INC., OTHERS

The Atlanta Regional and Miami Branch Offices filed a complaint on November 6 in the U.S. District Court for the Southern District of Florida, charging Western Gold, Inc., U.S. Exploration Corporation, Professional Marketing Consultants, Inc. and Ronald Nagorniak, aided and abetted by Vernon Brownstone, with violations of the antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934 and with the offer and sale of unregistered securities in violation of the Securities Act. The complaint also charges that Professional, aided and abetted by Nagorniak and Brownstone, violated the broker-dealer registration provisions of the Exchange Act.

On November 7, Judge Thomas E. Scott, U.S. District Court for the Southern District of Florida, entered a Temporary Restraining Order against the defendants, restraining them from violating the provisions cited in the complaint. The Court also entered an Order freezing the assets of Western Gold, U.S. Exploration, Professional and Nagorniak. A hearing on the Commission's Motion for a Preliminary Injunction was held November 14, 1985. (SEC v. Western Gold, Inc., et al., Civil Action No. 85-3506-CIV-SCOTT, SDFL). (LR-10934)

COMPLAINT FILED AGAINST FLUID LIFT INTERNATIONAL, INC., OTHERS

The Fort Worth Regional Office filed a complaint on November 4 in the U.S. District Court for the Northern District of Texas, Fort Worth Division, seeking Orders of Permanent Injunctions against Fluid Lift International, Inc., a publicly-held company located in Fort Worth, Texas, John Bell Walling, chairman of Fluid Lift, and the Cadasco Trust, Fluid Lift's largest shareholder.

All three defendants are alleged to have violated the registration provisions of the securities laws in the offer and sale of 1.8 million shares of Fluid Lift common stock for an approximate amount of \$2 million. It is further alleged that Fluid Lift and Walling violated the antifraud provisions of the securities laws by making false and misleading statements to the public concerning, among other things, projections of revenues derived from the sale of a purported submersible pumping system. (SEC v. Fluid Lift International, Inc., et al., USDC/NDTX/Fort Worth Div./CA 4-85-738K). (LR-10935)

INVESTMENT COMPANY ACT RELEASES

NARRAGANSETT CAPITAL CORPORATION

A notice has been issued giving interested persons until December 10 to request a hearing on an application filed by Narragansett Capital Corporation, Narragansett Management Partners, Narragansett First Fund, Arthur D. Little, Robert D. Manchester, William P. Lane, Gregory P. Barber and Roger A. Vandenberg requesting an order permitting certain proposed transactions and exempting those transactions from the provisions of Section 17(a) of the Investment Company Act. (Rel. IC-14797 - Nov. 15)

HOLDING COMPANY ACT RELEASES

COLUMBUS AND SOUTHERN OHIO ELECTRIC COMPANY

A notice has been issued giving interested persons until December 10 to request a hearing on a proposal by Columbus and Southern Ohio Electric Company, subsidiary of American Electric Power Company, to acquire a note in the amount of \$1.9 million as a provision of the previously authorized sale of three generating units. (Rel. 35-23907 - Nov. 15)

THE CONNECTICUT LIGHT AND POWER COMPANY

An order has been issued authorizing The Connecticut Light and Power Company, subsidiary of Northeast Utilities, to borrow \$60 million to construct generating facilities, and a request for an exception from competitive bidding. (Rel. 35-23908 - Nov. 14)

LISTING, DELISTING AND UNLISTED TRADING ACTIONS

WITHDRAWAL GRANTED

An order has been issued granting the application of CORADIAN CORPORATION to withdraw its common stock, par value \$.01, from listing and registration on the American Stock Exchange, Inc. (Rel. 34-22623)

SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved, on an accelerated basis, a proposed rule change filed by The American Stock Exchange, Inc. (SR-Amex-85-36) to amend its Rule 7 governing short sales to exclude listed bonds from the Rule's coverage, consistent with Rule 10a-1 under the Securities Exchange Act of 1934. (Rel. 34-22620)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed under Rule 19b-4 by the National Association of Securities Dealers, Inc. (SR-NASD-85-30) to amend its Rules of Fair Practice and Code of Procedure. The new section of the Rules of Fair Practice, Section 39, will require a broker-dealer firm that wishes to change its exempt status under the Commission's customer protection rule (17 CFR §240.15c3-3) to request and receive approval from the NASD before making the change. The amendment to the Code of Procedure explains the procedures the firm must follow to acquire NASD approval. (Rel. 34-22621)
