## ADMINISTRATIVE PROCEEDINGS

---

### FINDINGS AND SANCTIONS REGARDING NATIONAL BOND AND SHARE CO. ORDERED

The Commission announced the entry of Findings and Order Imposing Remedial Sanctions under Section 17A(c) of the Securities Exchange Act of 1934 in the Matter of National Bond and Share Co., a registered transfer agent located in Denver, Colorado. The Findings and Order was entered pursuant to provisions in 17 CFR §§201.6(e) and 201.7(b) and (e) for default, based on National's failure to file an Answer to the Order or enter an appearance.

Findings were entered that National wilfully violated Sections 17(a), 17(b), 17A(d), 17f(1) and 17f(2) of the Exchange Act and certain rules thereunder by refusing to allow staff inspection of its books and records and failing to comply with various books and records provisions relating to transfer agents. National's registration as a transfer agent was revoked. (Rel. 34-19638)

### PRESIDENT OF NEW JERSEY BOND DEALER SUSPENDED

The Commission announced the 60-day suspension of Herbert N. Goettlich, president of First Interregional Equity Corp., a northern New Jersey municipal securities dealer with offices in Florida and New York City. Goettlich consented to the suspension and to the entry of findings of violations and aiding and abetting violations of the securities laws without admitting or denying the charges.

The Commission had alleged that Goettlich approved excessive mark-ups; aided and abetted the firm's alleged bookkeeping violations in connection with currency transactions; aided and abetted the firm's alleged violations of confirmation delivery rules; and failed reasonably to supervise persons under his supervision who committed violations alleged by the Commission. ## HOLDING COMPANY ACT RELEASES

### NORTHEAST UTILITIES

An order has been issued authorizing Northeast Utilities, a registered holding company, to issue and sell at competitive bidding, in one or more sales during the period ending December 31, 1983, up to six million shares of common stock, \$5 par value, and also to make capital contributions during the same period to its subsidiaries, Western Massachusetts Electric Company and Connecticut Light and Power Company, of up to \$40 million and \$70 million, respectively. Jurisdiction has been reserved over the issuance and sale of an additional two million shares of common stock. (Rel. 35-22905 - Apr. 7)

### AMERICAN ELECTRIC POWER COMPANY, INC.

A notice has been issued giving interested persons until April 29 to request a hearing on a proposal by American Electric Power Company, Inc. (American), a registered holding company, and American Electric Power Service Corporation (Services), to issue up to \$15 million of unsecured notes through March 31, 1984, at a fixed rate of interest up to 200 basis points above the prime rate at the time such notes are issued, for terms of not less than two nor more than ten years. The proceeds of the notes will be used to refinance a like amount of unsecured notes bearing a fluctuating interest rate equal to the prime rate. ### NOTICE OF EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by The Options Clearing Corporation pursuant to Rule 19b-4 (SR-OCC-83-6) has become effective in accordance with Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposed rule change would amend OCC's foreign currency settlement procedures to allow OCC to pay settlement money in respect of foreign currency that has been delivered to OCC's foreign correspondent bank either (a) to the delivering clearing member, or (b) if the delivering clearing member so authorizes, directly to a bank designated by the delivery clearing member and approved by OCC. Publication of the proposal is expected to be made in the Federal Register during the week of April 11. (Rel. 34-19656)
