## INVESTMENT COMPANY ACT RELEASES

INTERNATIONAL INVESTORS INCORPORATED

U.S. SECURITIES AND  
EXCHANGE COMMISSION

An order has been issued on an application by International Investors Incorporated (International), an open-end investment company, and I.I.I. Securities Corporation, International's principal underwriter, permitting them to offer shares of International in exchange for shares of Standard & Poor's/InterCapital Liquid Assets Fund, Inc. upon payment of a \$5 exchange fee but without the customary sales charges described in International's prospectus. (Rel. IC-9248 - Apr. 16)

JOHN HANCOCK INVESTORS, INC.

An order has been issued on the application of John Hancock Investors, Inc. (Investors) a closed-end diversified management company, and John Hancock Mutual Life Insurance Company (the Life Company), permitting (1) the Life Company to purchase in a private placement \$7 million principal amount of Harnischfeger Corporation (Harnischfeger), 9-7/8% promissory notes due March 1, 1972 (New Notes), and (2) Investors, as one of the holders of Harnischfeger 9% promissory notes due December 1, 1991 (Old Notes) (a) to consent to the issuance of the New Notes, and (b) to approve certain amendments to the financial covenants contained in the Old Notes. STATE STREET EXCHANGE FUND

KEMPER MUNICIPAL BOND FUND

An order has been issued on an application of Kemper Municipal Bond Fund, Ltd., a Nebraska limited partnership, exempting the fund from (1) Section 2(a)(19), so that the general partners will not be deemed to be interested persons of the fund solely by reason of being partners thereof; and (2) Section 18(f)(1), to the extent that the fund may be deemed to have issued a "senior security" as a result of certain priorities upon dissolution which extend to the limited partners. SOUTHWESTERN ELECTRIC POWER COMPANY

An order has been issued authorizing Southwestern Electric Power Company, subsidiary of Central and South West Corporation, to issue and sell \$45 million principal amount of its first mortgage bonds at competitive bidding. (Rel. 35-19490 - Apr. 19)

The shares of convertible preferred stock are proposed to be issued pursuant to an Agreement of Merger providing for the merger of Safeguard Automotive Corporation, a 79% owned subsidiary of Safeguard Industries, into NEWSAC, INC., a newly organized wholly-owned subsidiary of Safeguard Industries, as a result of which the publicly held shares of Safeguard Automotive Corp. common stock will be exchanged for the convertible preferred stock at the rate of one share of convertible preferred stock for two shares of common stock. Safeguard Industries' primary operations are conducted through its principal subsidiaries, Safeguard Automotive Corp., a producer of automotive replacement parts and power transmission products, and Safeguard Business Systems, Inc., which produces and markets "one write" accounting systems, provides data processing services, and manufactures and markets a variety of printed business forms.
