

Summary Report of Occurrences Reviewed From January 18 – 22, 2010

Summary: 26 occurrences at 10 sites reviewed during this period.

Occurrences of Significant Interest (1)

Safeguards & Security – 1 occurrence at 1 site

- **NA – Pantex Plant (Significance Category OE).** On January 15, a Pantex employee observed armed individuals dressed in camouflage exiting a van en route to the perimeter of the Pantex Plant. An Operational Emergency at the Alert level was declared. All plant employees sheltered in place and operations were suspended. After Pantex Security located the individuals and questioned them, it was determined that there was no security risk to the Plant. The individuals were DOE employees assigned to the Pantex Plant who were legally hunting ducks on property near the plant. The Operational Emergency was terminated and all operations were returned to normal.
