Summary Report of Occurrences Reviewed From August 23 – 27, 2010

Summary: 32 occurrences at 18 sites reviewed during this period.

Occurrences of Significant Interest (1)

Injury – 1 occurrence at 1 site

• <u>NA – Y12 National Security Complex (Significance Category 3).</u> On August 25, during semi-annual firearm qualifications at the Central Training Facility (CTF) with a Dillon M134D Aero Minigun mounted in the turret of a Lenco Bearcat, a firearms instructor received minor injuries when he was struck by fragments during a string of fire. The fragments occurred when the barrel clamp/flash suppressor on the gun loosened and moved forward, causing it to be struck by bullets during a burst of gunfire. The instructor received a cut to his forehead, and small fragments in his left knee and right forearm. He also injured his right forearm while moving to a prone position during the incident. He was transported by ambulance to the University of Tennessee Medical Center in Knoxville, TN. The medical staff removed the small, visible fragment from his knee but did not remove anything from his forearm. He was released back to work. An investigation team initiated an event review. Minigun training at the CTF was suspended until the investigation is completed and it is determined that training may be safely continued. All operational miniguns were checked and it was verified that all are serviceable and properly installed.
