Summary Report of Occurrences Reviewed From October 18 – 22, 2010

Summary: 26 occurrences at 11 sites reviewed during this period.

Occurrences of Significant Interest (1)

Injury – 1 occurrence at 1 site

NA -Kirtland Office, Craddock A Facility (Significance Category 3). On October 18, a construction subcontractor with 4-C's Industrial Inc. was struck on his hard hat by falling cast iron piping fittings (a 4-inch elbow and a collar). A Kaufman Fire Protection construction subcontractor, working on a scissors lift, was installing a cast iron 90-degree elbow onto a 4-inch water line. A cast iron collar was used as the coupler. While tightening a 3/8-inch carriage bolt to the collar, the bolt snapped in half allowing the collar to fall apart and, along with the elbow, fall approximately 15 feet to the floor. The 4-C's subcontractor, working at floor level within five feet from the overhead work, was struck on the back side of his hard hat, and on the unprotected portion of the back side of his head causing a laceration. The worker did not lose consciousness, but stumbled backwards a few feet. The subcontractor was taken to the hospital by ambulance for treatment. The manager for the Craddock A Facility secured the area and stopped work. Photographs of the scene were taken. Witnesses and other personnel involved in the incident were interviewed. Appropriate notifications were made. Resulting actions include: (1) ensuring there is a spotter to keep persons out of the hazard zone while overhead work is being performed; (2) verifying that the installed bolts meet specifications and are not suspect/counterfeit; and (3) holding daily joint meetings to discuss and coordinate work activities, hazards, and site safety.
