

Summary Report of Occurrences Reviewed From October 8 – 12, 2007

Summary: 21 occurrences at 14 sites reviewed during this period.

Significant Occurrences (2)

Injury – 1 occurrence at 1 site

- ***NA – Los Alamos Site (Significance Category 3).*** On October 8, 2007, a worker sustained a serious occupational injury when a roll cart weighing approximately 2,500 lbs rolled over the toes of his left foot. The worker, who was in training status, entered the real time radiography vault to verify if traveler documents taped to drum lids were signed. To accomplish this, the worker stood on the rails on which the roll cart runs. After the worker confirmed that the travelers were signed, an operator began the auto-out sequence which results in the roll cart moving automatically. The operator and a recorder heard the worker yell, and hit the emergency stop button. The worker was transported to the hospital by ambulance.

Near Misses – 1 occurrence at 1 site

- ***EM – Idaho National Laboratory (Significance Category 3).*** On October 4, 2007, a new network server lifting unit, being delivered to the Information Operations and Research Center (IORC), fell off the delivery truck. The 400-pound unit fell 4 feet to the asphalt parking lot as it was being moved from the truck bed to the hydraulic tailgate with a pallet jack. Two IORC personnel, who were attending the delivery, were standing on the parking lot near the tailgate. The server lift unit, valued at less than \$10,000 was damaged and rendered unacceptable for use. No personnel were injured during the event.
