Description of The CSFC Program:

The Commercial Solutions for Classified (CSFC) Program is created by the National Security Agency. The program allows clients to deploy COTS products in national security networks to protect both the systems and the classified information contained within. The CSFC Program is not designed to approve a single product but to allow COTS products to be used in a layered solution to protect national security systems that contain classified information.

The intent of this questionnaire is for vendors to have their product(s) be considered for the "CSFC Components" listing. The CSFC Solution Designer will draw products from the publicly-accessible "CSFC Components" list to create composed solutions for a class of security problems. When a product is added to the list, it does not equate to NSA approval or endorsement of the product. It simply states the product has met its CSFC requirements and is qualified/eligible for use in the composed solution. Vendors may self-nominate their product(s) or may be sponsored by a Government.

Requirements:

For the product to be considered for the CSFC Program, the product must be National Security Telecommunications and Information System Security Policy (NSTISSP) No. 11 compliance. Complete Sections B, C, D, & E and return the form to BAO@nsa.gov. You may attach additional supporting documents (e.g. white paper, product specification, etc.) pertinent to the product. Each product will require a separate CSFC questionnaire form.
