# ***CLAIMS***

---

- **HHG Claims** – Be proactive, ask the shipper for info to file claim for damage
- **Vehicle Shipment** – Thoroughly inspect exterior and interior prior to leaving the port
- **GOV/POV accidents** – report immediately
- **Incident to Service** - Wind, power surge, theft/vandalism
- **Tell us if someone damages Government property!**



# ***LOCAL LEGAL ISSUES***

---

- SOFA: Technical Agreement and NATO SOFA
- Cottages: DO NOT BUY!!! Portugal wants them back!
- Buying a US vehicle vs. P plated car
- Black marketing
- Want to hire a nanny? Housekeeper?
  - Talk to our Dr. Lemos first
  - If you don't, HAAZ will not give your employee a base pass!



# ***LOCAL LEGAL ISSUES***

## ***CONT.***

---

- Getting married here? Having a baby on the island? Call to talk to Sra Machado (after you talk to FSS)
- No ordering of Cuban cigars
  - 31 C.F.R. § 515.204 - No purchase, transport, import, or dealing in a transaction if merchandise is from Cuba
  - It does not matter where you buy it!



# ***LOCAL LEGAL ISSUES***

## ***CONT.***

---

- Dangerous Dog Breeds
  - Portuguese law
  - Brazilian Mastiff, Argentine Dogue, Pit Bull Terrier, Rotweiller, American Staffordshire Terrier, Staffordshire Bull Terrier, and Tosa Inu
  - Register and get permit at Town Hall
  - License renewed annually
  - Insurance policy of 50,000 Euro
  - Fines can be up to 3,740 Euro



# ***Area Defense Counsel (ADC)***

---

- An appointed military counsel under a separate chain of command. Handles matters such as:
  - LORs
  - Referral EPRs,
  - Article 15s,
  - Courts-martial, etc
  
- ADC for Lajes Field
  - Located at Ramstein AB, Germany
