

Wisconsin: Exports, Jobs, and Foreign Investment February 2013

Exports Support Jobs for Wisconsin's Workers

Export-supported jobs linked to manufacturing account for an estimated 6.5 percent of Wisconsin's total private-sector employment. nearly one-fifth (19.4 percent) of all manufacturing workers in Wisconsin depend on exports for their jobs (2009 data latest available).

Exports Sustain Thousands of Wisconsin Businesses

A total of 6,847 companies exported from Wisconsin locations in 2010. Of those, 6,042 (88 percent) were small and medium-sized enterprises with fewer than 500 employees.

Small and medium-sized firms generated over one-quarter (28 percent) of Wisconsin's total exports of merchandise in 2010.

Foreign Investment Creates Jobs in Wisconsin

In 2010, foreign-controlled companies employed 76,000 Wisconsin workers. Major sources of foreign investment in Wisconsin in 2010 included Canada, Germany, United Kingdom, and Switzerland.

Foreign investment in Wisconsin was responsible for 3.3 percent of the state's total private-industry employment in 2010.

Wisconsin Depends on World Markets

Wisconsin's export shipments of merchandise in 2012 totaled \$23.1 billion.

The state's largest market was Canada. Wisconsin posted merchandise exports of \$7.6 billion to Canada in 2012, 33.0 percent of the state's total merchandise exports. Canada was followed by Mexico (\$2.2 billion), China (\$1.5 billion), Australia (\$865 million), and Japan (\$863 million).

The state's largest merchandise export category is Machinery, Except Electrical, which accounted for \$7.0 billion of Wisconsin's total merchandise exports in 2012. Other top merchandise exports are Computer & Electronic Products (\$3.0 billion), Transportation Equipment (\$1.8 billion), Food & Kindred Products (\$1.7 billion), and Chemicals (\$1.6 billion).

Wisconsin's Metropolitan Exports

In 2011, the following metropolitan areas in Wisconsin recorded merchandise exports: Milwaukee-Waukesha-West Allis (\$8.8 billion), Madison (\$2 billion), Racine (\$1.3 billion), Oshkosh-Neenah (\$1.3 billion), Appleton (\$1.1 billion), Green Bay (\$1 billion), Janesville (\$834 million), Sheboygan (\$622 million), Eau Claire (\$546 million), Fond du Lac (\$468 million), Wausau (\$281 million), La Crosse (\$688 million, portions of this MSA are shared with one or more other states)
