## **Ground rules**

1. The Moderator controls scenario time and discussion time during Table Top.
2. Participants should stay in their emergency response role throughout conduct of the Table Top. Have fun with it!
3. Please do not debate technical accuracy or timeline of scenario during conduct of the Table Top.
4. When discussing actions, decisions and communications that you would undertake in your emergency position speak loud enough for all to hear.
5. During the TT is the time to identify program/system problems. Following the TT is the time to determine cause and correction of program/system problems.

## **Objectives**

Given an emergency event: *Initial and follow-up emergency notifications must be made promptly, accurately and effectively to workers and emergency response personnel/organizations, appropriate DOE/NNSA elements, and other Federal, Tribal, State, and local organizations and authorities.* – In accordance with DOE Order 151.1C

Given an emergency event: *Continuous, effective, and accurate communication among response components and/or organizations must be reliably maintained throughout an Operational Emergency.* – In accordance with DOE Order 151.1C

Given an emergency event: *Effective interfaces must be established and maintained to ensure that emergency response activities are integrated and coordinated with the Federal, Tribal, State, and local agencies and organizations responsible for emergency response and protection of the workers, public, and environment.* – In accordance with DOE Order 151.1C

Given an emergency event: *Accurate, candid, and timely information must be provided to workers, the news media, and the public during an emergency to establish facts and avoid speculation.* – In accordance with DOE Order 151.1C

Given an emergency event: *Emergency public information efforts must be coordinated with DOE and NNSA (if appropriate); State, local, and Tribal governments; and Federal emergency response organizations, as appropriate.* – In accordance with DOE Order 151.1C

Given an emergency event: *Control and coordination at the event/incident scene is consistent with the NRP and the NIMS/Incident command system (ICS), which integrates local agencies and organizations that provide onsite response services.* – In accordance with DOE Order 151.1C

- Normal day shift of employees (3,200) are on duty
- Security posture is normal (security condition 3)
- Weather
  - Wind from 220 degrees, 7 MPH, Temp 78 degrees, Stability D
  - Humidity 62%, No precipitation
- Movement of ten 55-gallon drums (DOT approved) of acetonitrile (ACN) is scheduled for delivery at the Uranium Processing Facility (UPF).
  - One driver and two Material Handlers
  - UPF is a new facility that recently began operations. New Operations Manager recently hired
- UPF is awaiting delivery
  - Electric forklift, One Supervisors, 3 Chemical Operators
  - Processing operations in progress (32 additional employees)
