Dear Ms. Lerner:

This is in response to your letter of September 6, 2011, to the Secretary of Defense referring for investigation a whistleblower disclosure regarding employees at the Defense Commissary Agency (DeCA) (OSC File Number DI-11-3431). The whistleblower alleged that DeCA employees engaged in conduct that may have constituted a violation of law, rule, or regulation, gross mismanagement, and a substantial and specific danger to public safety.

By memorandum from the Secretary of Defense dated February 9, 1998, the DoD Inspector General has been delegated authority to respond to requests for investigations under 5 U.S.C. § 1213. As indicated in our previous correspondence dated September 14, 2011, and November 15, 2011, the Defense Hotline directed the U.S. Army Criminal Investigation Command (CID) to conduct an investigation. CID completed their investigation and a copy of their report is enclosed for your use and transmittal to the President and appropriate congressional committees.

We have reviewed the CID report, concur with its conclusions, and believe the enclosed report satisfies the requirement of 5 U.S.C. § 1213. CID determined that the allegations made by the whistleblower, Mr. Fred Bey, were unfounded. Further, consistent with OSC policy to interview a whistleblower who has consented to release of his name, a Defense Hotline investigator interviewed Mr. Bey, who had no additional information to offer on the matter.

In addition to the unredacted CID report, we have enclosed a redacted copy that may be publicly posted. Because personal information in the unredacted report is exempt from public release under the Freedom of Information Act (FOIA), the report is designated "FOR OFFICIAL USE ONLY." We ask that you coordinate any additional releases of the unredacted report with our FOIA Requester Service Center/Privacy Act Office, Office of the Inspector General of the Department of Defense, 4800 Mark Center Drive, Alexandria, Virginia, 22350-1500.

We provided you with a report of investigation, prepared by the U.S. Army Criminal Investigation Command (CID). The report was redacted pursuant to Exemptions 6 and 7(C) of the FOIA, specifically, 5 U.S.C. § 552(b)(6), which pertains to information, the release of which would constitute a clearly unwarranted invasion of personal privacy; and 5 U.S.C. § 552(b)(7)(C), which pertains to information compiled for law enforcement purposes, the release of which could reasonably be expected to constitute an unwarranted invasion of the personal privacy of third parties.

6. Scope of Examination, Conclusion, and Recommendations:		
a. On 9 Dec 11, HQ USACIDC received a DODIG HL Action Referral 121445 from DODIG. The referral contained allegations from Mr. Fred BEY, Defense Commissary Agency (DECA), Joint Base Myers-Henderson Hall (JBM-HH). Mr. BEY reported that DECA, JBM-HH, was selling drugs to other employees at the JBM-HH Commissary, and that JBM-HH, allegedly stored a gun and ammunition in his work locker. Mr. BEY's reported the allegation as a Whistleblower Disclosure to the Office of the Secretary Defense.	of	
b. Interviews with the JBM-HH Commissary Director Commissary Manager indicated that they both questioned the credibility of the complainant. Both the and indicated they received a similar allegation in the past and reported the matter to the Military Police (MP). The MP conducted a search of the employee's locker area wi MP Working Dogs and found no illegal drugs.		
c. An interview of supervised Mr. BEY for a short period of time. During this tenure at the Commissary, the DECA never received any complaints of this manner against period in Jun 11, Mr. BEY tried to make a similar allegation that he was in possession of drugs. During this incident, a Military Police K-9 responded to the Commissary and conducted a search of his locker area. No controlled substances were found. If further denied he ever possessed, used or sold controlled substances and allowed CID Agents to search his locker and personal items. The search found nothing of evidential value.	nd	
d. An interview of revealed he also worked as a DECA employee for over 20 years and was also Mr. BEY's supervisor for a short period of time. denied ever bringing a firearm or ammunition to the Commissary and

further denied that he ever owned a firearm. also allowed CID to search his locker and personal items, but the search failed to find any contraband or prohibited items. related the employee locker room and warehouse areas of the commissary are routinely utilized by the MP Working Dog Section for training and have been searched multiple times during the last few years.

- e. Coordination with the Kennel Master of the Military Working Dog Section, JBM-HH, verified the statements of individuals above. The Kennel Master indicated the MP Working Dog Section routinely conducts drug and explosive dog training in the Commissary and the MP Working Dogs never alerted on any drugs or weapons during their training searches. Furthermore, checks of the MP Reporting System confirmed the MP responded to a previous allegation about an employee having illegal drugs. The report further indicated the MP searched the area with MP Working Dogs, found no illegal drugs and determined the allegations were unfounded.
- f. Examination of the JBM-HH Commissary employee locker room and the lockers of and The examination revealed the lockers utilized by employees were stand-up medal grate type locker, wherein all contents within the lockers are visible from the outside. This type of locker makes it difficult to hide items inside the lockers. The subsequent search of lockers found no illegal drugs.
- g. Based on the totality of the investigation, there is no credible information to substantiate the allegations provided by Mr. BEY. No further action by CID is anticipated.
- 7. Cite Criminal or Regulatory Violations Substantiated: None.
- 8. <u>Disposition</u>: During the scope of this investigation no criminality was identified or discovered.
