Lois Haight Herrington is a practicing attorney who has served as a deputy district attorney, probation officer, and counselor in Juvenile Hall in California. Ms. Herrington previously maintained a private law practice. She has also been a member of the Alameda County Women's Coalition on Domestic Violence, the Contra Costa County Child Development Council, the California Sexual Assault Investigators Conference and Juvenile Justice Conference. Additionally, Ms. Herrington has served as a coordinator for Probation and Courts for Domestic Violence Diversion programs and an instructor for Drug Diversion and Education Program, and a volunteer vocational counselor at a California high school.

Garfield Bobo is a Court Assistant for the Supreme Court of New York. He has also held positions as President of the Bedford-Stuyvesant Improvements Association and as a member of the Urban League of Greater New York.
