

## 2.4 Data Files.

### a. Introduction.

This section contains record formats for the files used in the system. All files are sequential and do not require direct access storage.

Two files are used primarily by the system and are called the Master and Report Files. The Master File and the Edit/Update input transaction file formats are identical and these formats are described in the following pages under Master File. The Report File which is the output of the Report File Generation program is described under Report File.

All the NFDC files created by NFDCOUT will be compatible with the states files.

### b. Master File.

The Master File contains a series of records identified by a record type code. The file is in sequence as follows:

Any merging of master files must use this key structure exactly as shown or major problems will be encountered due to invalid master file sequence. The record types contained in the Master File are as follows:

<u>Record Type</u>	<u>Record</u>
01	Fire Department Identification: Always present at beginning of each set of fire department records.
05	Report of Submitted Incidents: Immediately follows the FDID record and each fire department may have one of these records for each month.
10,11, 12,20	Incident Record: These records will contain all the NFIRS-1 Incident Information except for equipment (and mobile property) data.

<u>Record Type</u>	<u>Record</u>
30	Mobile Property Records from Line S on NFIRS-1.
31-35	Hazardous Materials Incident Records. These records contain the NFIRS-HMI data.
40	Equipment Records from Line T on NFIRS-1.
50	Civilian Casualty Records: These records contain the NFIRS-2 data for Civilian Casualties.
52	Fire Service Casualty Records: These records contain the NFIRS-3 data.
55	Casualty Trailer Record: This is an internally generated and maintained record which contains the number of deaths and injuries. This record is transparent to the user.
60-79	User Records: These records will correspond to the input record types and are for user information. Record Types 70-79 are to be used to comment on Hazardous Materials Incidents, and 60-69 are for general comments.

All record types may not be present for all incidents. A particular record type will only be present if any of the data stored on that record is present for a given incident, e.g., a type 50 record will be present only if there is a civilian casualty.
