WAGE/FRINGE BENEFIT ADJUSTMENT - ELECTRICIANS

I have received a letter from the Business Manager of IBEW Local Union No. 270, W. Ray Day, requesting that the Wage/Fringe Benefit Rate for Electricians be adjusted in order to keep pace with increases in contributions needed for the Health and Welfare Fund. Effective January 1, 2013 the contribution to the H&W Fund will increase by \$0.20/hr to a new total of \$5.50/hr. In order to fund this increase, Local #270 has requested that the hourly contribution to the Retirement Fund be reduced by \$0.20/hr to a new total of \$5.30/hr. Therefore, the wage rates for all classifications will remain the same; the only changes will be in Fringe Benefits.
