IMPORTS AND EXPORTS OF FISHERY PRODUCTS ANNUAL SUMMARY, 2005

IMPORTS. U.S. imports of edible fishery products in 2005 were valued at \$12.1 billion, \$768.0 million more than in 2004. The quantity of edible imports was 2,320,120 metric tons, a 74,449 tons increase from the quantity imported in 2004.

The quantity of shrimp imported in 2005 was 528,836 tons, 11,219 tons more than the quantity imported in 2004. Valued at \$3.6 billion, shrimp imports accounted for 30 percent of the value of total edible imports. Imports of fresh and frozen salmon, including fillets, were 221,171 tons valued at \$1.1 billion in 2005. Imports of fresh and frozen tuna were 178,577 tons, 6,211 tons less than imported in 2004. Imports of canned tuna were 205,056 tons, 3,978 tons more than in 2004. Imports of fresh and frozen fillets and steaks amounted to 520,069 tons, an increase of 35,127 tons from 2004. Regular and minced block imports were 63,054 tons, an increase of 1,619 tons from 2004. Edible imports consisted: of 1,913,714 tons of fresh and frozen products valued at \$10.5 billion; 339,317 tons of canned products valued at \$1.2 billion; 37,547 tons of cured products valued at \$186.3 million; 3,516 tons of caviar and roe products valued at \$40.5 million; and 26,026 tons of other products valued at \$135.2 million.

Imports of nonedible fishery products were valued at \$13.0 billion, \$1.4 billion more than imported in 2004. Total value of edible and nonedible products was \$25.1 billion in 2005, \$2.2 billion more than in 2004, when \$22.9 billion of fishery products were imported.

EXPORTS. U.S. exports of edible fishery products of domestic origin were 1,290,926 tons valued at \$3.8 billion, compared with 1,275,765 tons at \$3.5 billion exported in 2004.

Fresh and frozen items were 1,098,799 tons valued at \$2.9 billion, an increase of 7,742 tons and \$265.0 million compared with 2004. Fresh and frozen exports consisted principally of 131,556 tons of salmon valued at \$406.2 million, 25,584 tons of lobster (*Homarus spp.*) valued at \$335.5 million, and 206,019 tons of surimi valued at \$423.5 million. Canned items were 95,919 tons valued at \$261.4 million. Salmon was the major canned item exported, with 51,776 tons valued at \$177.4 million. Cured items were 4,155 tons valued at \$17.0 million. Caviar and roe exports were 57,185 tons valued at \$545.6 million. Other edible products accounted for 34,868 tons valued at \$71.8 million.

Exports of nonedible products were valued at \$9.7 billion. Exports of fish meal amounted to 163,211 tons valued at \$98.2 million. The total value of edible and nonedible exports was \$13.5 billion, \$1.4 billion more than in 2004.

RE-EXPORTS. U.S. exports of edible fishery products of foreign origin were 37,851 tons valued at \$232.4 million, compared to 34,301 tons valued at \$210.3 million re-exported in 2004. Fresh and frozen items were 34,636 tons valued at \$210.9 million an increase of 5,339 tons and \$35.0 million compared with 2004. Fresh and frozen tuna was the principle product at 3,154 tons valued at \$39.3 million. Canned items accounted for 1,303 tons valued at \$7.4 million. Cured products were 766 tons valued at \$5.5 million. Caviar and roe re-exports were 506 tons valued at \$5.4 million. Other edible products were 640 tons valued at \$3.3 million.

Re-exports of nonedible fishery products were valued at \$1.7 billion. Fish oils accounted for 2,920 tons valued at \$4.4 million. The total value of edible and nonedible re-exports was \$1.9 billion, \$425.1 million more than in 2004.

NOTES. Unless otherwise noted, the information presented is based on U.S. Census Bureau data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of "domestic" merchandise to include commodities, which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of "foreign" products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacture. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the "Customs value." It is based on the value of the product in the country of origin as appraised by the U.S. Customs and Border Protection, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
