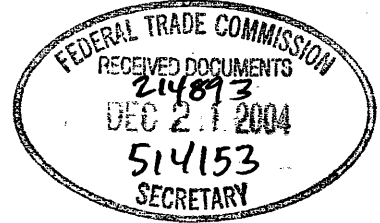

**CONSENT NOTICE**


Pursuant to the Parties' Notice to the Court dated December 20, 2004, the parties hereby respectfully notify that Court that they have reached the following agreement:




