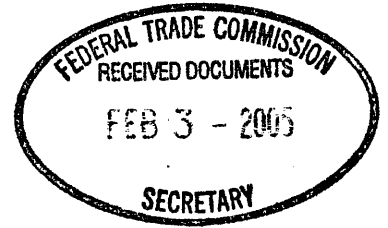

**RESPONDENTS' CONSENT MOTION FOR LEAVE TO FILE
SUPPLEMENTAL MEMORANDUM IN SUPPORT OF MOTION FOR *IN*
CAMERA TREATMENT OF CERTAIN TRIAL EXHIBITS**

Respondent Evanston Northwestern Healthcare Corporation (“ENH”) respectfully submits this Consent Motion for Leave to File Supplemental Memorandum in Support of Motion for *In Camera* Treatment of Certain Trial Exhibits. ENH has attached to this Motion a copy of the Supplemental Memorandum with an Amended Exhibit A as well as a Supplemental Brian Washa Declaration.

On January 4, 2005, ENH filed a Motion for *In Camera* Treatment of Certain Trial Exhibits. ENH requests leave to file the contemporaneously-filed supplemental memorandum in support of that motion for two purposes. First, as requested by the Court, and in light of the proposed settlement of Count III, ENH seeks to substantially reduce its original list of trial exhibits for which it seeks *in camera* treatment. 
that each exhibit remain sealed. ENH respectfully refers the Court to the enclosed memorandum, which addresses in more detail the revisions at issue.
