**RESPONDENTS' MOTION TO EXTEND TIME FOR FURTHER BRIEFING ON
SPECIFIC REMEDY ISSUES**

On May 16, 2005, Respondents Chicago Bridge & Iron Company and Chicago Bridge & Iron Company N.V. ("CB&I") were served with the Commission's Decision and Order Partially Denying Respondents' Petition for Reconsideration and Directing Further Briefing on Specific Remedy Issues ("Decision and Order"). The Commission's Decision and Order directs Respondents to "file a brief within 10 days of service of this Decision and Order" identifying assets in the "Relevant Business" definition that are unnecessary to build the relevant products and water tank products in light of certain facts outlined by the Commission. *See* Decision and Order, p. 24. The Decision and Order also allows Respondents to include an alternative suggestion for a divestiture package consistent with certain factual findings of the Commission. *See id.*

Pursuant to the time schedule set forth by the Decision and Order, Respondents' briefing is due on or before May 26, 2005. Respondents will need additional time to conduct the review

and analysis necessary to properly respond to the Decision and Order. Accordingly, Respondents request an extension until June 6, 2005 to file the briefing directed by the Decision and Order.


