The parties' Statements of Positions following the Board's acceptance of the remand from the Second Circuit Court of Appeals are currently due on October 19, 2012. As Counsel for Planned Building Services has previously informed your office, the parties desire to settle this matter and thereby obviate the need to submit statements to the Board. I am writing to request an extension of time to file the Statements of Position from October 19 to January 18, 2013. The requested extension of time is warranted to allow the Regional Office additional time to complete the vast and complex compliance investigation, which has been additionally complicated by the Region's inability to locate a number of the affected employees to obtain their relevant back pay information. The requested time is further warranted to allow the parties adequate time to review the Region's calculations and to negotiate and finalize an agreement.
