GUIDELINE FOR THE COMPLETION OF THE FSIS LETTERHEAD ADDENDUM CERTIFICATE TO EXPORT FROZEN OR CHILLED RAW POULTRY MEAT TO CHILE

- Strikeout the certification statement that does not agree with the signed statement provided by the APHIS accredited industry veterinarian responsible for the flock of origin. The signed statement by the APHIS accredited industry veterinarian will only accompany a flock to live bird receiving when birds have been vaccinated with a Killed Virus vaccine for AI. (Typically the first option is the correct one, and the second alternative would be lined out by the certifying plant veterinary official.)
- 2. Enter the city and state where the letterhead certificate is signed.
- 3. Enter the date the FSIS signing official signs the letterhead certificate.
- 4. The signing official stamps this block with the export stamp and enters their initials where the number would normally appear.
- 5. FSIS certifying official signs certificate.
