Objective #2: Collaboration with other EMI SIG groups

Objective #3: Development of a new media support statement

DOE sites have been admitted access to approved social media sites. However, admittance for use varies at each site. Plans and procedures need to be revised in order to reach constituents in a timely manner and within IT policies. EPI Subcommittee Chair, Erin Ritter, developed social media guidance for Pantex and will incorporate language from this guidance into the Draft New Media Support Statement for the Subcommittee to review. The final New Media Support Statement will outline the need and provide recommended guidance for social media use at DOE sites. Once finalized, this document will be presented to DOE HQ for consideration.

Path forward:

The EPI Subcommittee will review the D*raft New Media Support Statement* and provide Bernie Pleau (<u>letstalksense@q.com</u>) or Holly Jacobs Hardin (<u>holly.jacobs@orise.orau.gov</u>) items that should be included in the EPI Subcommittee Statement. The draft statement will be reviewed by the Subcommittee prior to the March 17, 2010, conference call.
