This may help instruct a document which provides suggestions to best manage and coordinate information with the FBI while also meeting DOE requirements.

The Oak Ridge Office (ORO) Joint Information Center (JIC) requests input on how sites are using new technology for media monitoring capabilities. Currently, the ORO JIC uses three radios and audio tapes to capture radio play and six TV/VHS combos to record local and national TV news coverage.
