### **Denny Park Apartments**

The planning and design of Denny Park Apartments, a 50-unit development of affordable housing serving families in the South Lake Union area of Seattle, will create several benefits for residents and the surrounding community. These include storm water retention through collection of water in landscaping planters, durable 50-year exterior materials (roofing and siding), efficient centralized heating and hot water system, maximum natural lighting, energy efficient lighting and controls, continuous ventilation of bathrooms for moisture control, and low maintenance landscaping. # **Free Energy Auditing Software**

The United States Department of Energy (DOE) has energy audit software available free of charge. The software, Weatherization Assistant version 7.4.3, was developed for the Weatherization Assistance Program (WAP) and is available at <a href="http://www.waptac.org">http://www.waptac.org</a>. Look under "Technical Tools" and click on "Energy Audits." Downloading instructions (which include a password) and manuals for the software are also available in PDF format at this location.

While there is not sufficient funding to provide technical support to those outside the WAP, you may use this software without further authorization from DOE. You may use multiple installations of the software, but DOE asks that if it is distributed to other establishments, they also register.

# **Cooling Equipment Inspection and Maintenance**

It's springtime and as warmer weather approaches it's time to have your cooling equipment inspected and serviced to be sure it is running at top efficiency. It's also a good time to perform some do-it-yourself maintenance tasks such as cleaning filters and coils and repairing leaks.

Many new and improved types of cooling system controls are now available and should be considered

as part of a multifamily housing rehabilitation project.

### ENERGY STAR® IN FOCUS

#### **ENERGY STAR for New Homes**

Nearly 10 percent of all homes built in 2004 earned the ENERGY STAR label. Since 1995 over 360,000 of the Nation's new homes have earned the ENERGY STAR, saving homeowners an estimated \$200 million and eliminating approximately 4 billion pounds of greenhouse gas emissions. Any single-family or multi-family residential home that is three stories or less in height can qualify to receive the ENERGY STAR label.



ENERGY STAR qualified homes are independently verified to be at least 30% more energy efficient than homes built to the 1993 national Model Energy Code or 15% more efficient than the state energy code, whichever is more rigorous. These savings are based on heating, cooling, and hot water energy use and are typically achieved through a combination of building envelope upgrades, high performance windows, controlled air infiltration, upgraded heating and air conditioning systems, tight duct systems and upgraded water-heating equipment.

An ENERGY STAR qualified new home actually costs less because the home's utility bills are lower than those of non-ENERGY STAR homes. ### ENERGY WATCH

The average heating oil cost for January 2005 was \$1.80 per gallon delivered, compared to \$1.42 in January 2004. Prices rose an average of 2% in February 2005 and continue to rise. The good news is that there is something housing authorities can do to counteract this one-year 30% price hike: improve efficiency. HVAC tune-up cuts heating costs by up to 10% and weatherizing can reduce cost by an additional 20%.
