DOL must conduct extensive outreach, education, participant and compliance assistance programs as well as promulgate, under very tight time frames, model notices and regulations covering changes in COBRA eligibility and ARRA’s new premium assistance provisions. In addition, DOL must develop and implement a program that provides for expedited review and determination regarding an individual’s appeal of the denial of his or her request to be treated as an “assistance eligible individual” and thus entitled to a subsidy of 65 percent of the cost of the individual’s COBRA continuation health coverage for up to nine months. Notices are expected to be published next week.</p>
