Major Completed Actions (Short bulleted list of the major actions taken to date.)

Employment and Training Administration (ETA)

Maine's application for Unemployment Insurance Modernization funding is currently being reviewed by the Employment Training Administration and must be certified no later than July 30. Hawaii's final two-thirds funding is also under review and must be certified no later than August 14.

Preliminary data indicates that the Summer Employment Youth Program, which provides work-based training and experience, has enrolled 100,000 youth, ages 14-24 years during May and June 2009. The program is targeted to serve 125,000 youth through August 2009 (the first 200 days of Recovery Act implementation).

ETA continues to process the 1,557 petitions that have been filed since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. ETA is also providing training to State and Regional staff on petition processing and for program and policy functions, developing new reporting and Web requirements by the statutory deadline of August 17, and revising state reports.

Summer Youth Employment Program site visits, monitoring and technical assistance efforts conducted by ETA Regional Office representatives are ongoing through the end of September 2009.

The first monthly report of participation in Recovery Act-funded programs was due to the National Office on July 15, 2009. Two states and one territory are currently resolving technical system issues and will file their reports subsequently. A fully reviewed and publishable set of the data will be available by July 30, 2009. The reports provide information on participation in Workforce Investment Act formula-funded programs for adults, dislocated workers (including National Emergency Grants), and youth and Wagner-Peyser Act activities.

ETA continues to compile a weekly report, entitled the *Summer Youth Snapshot*, which provides highlights of Recovery Act-funded activities specific to the Summer Youth Employment Program from various program locations across the nation.

As of July 17, 2009, \$2.2 billion has been distributed to a total of 28 states for UI Modernization incentive payments.

Employee Benefits Security Administration (EBSA)

EBSA continues to respond to over 700 COBRA inquiries on a daily basis. There have been almost 110,500 since the enactment of the ARRA.

EBSA now has over 37,200 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with over 1,465,000 total visitors since enactment of the ARRA.

EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 5,992.

Major Planned Actions (Short bulleted list of the major planned actions)

The Department of Labor is reviewing a request for a National Emergency Grant (NEG) by the State of Delaware. If approved, resources made available under the Recovery Act will fund \$3.8 million with around \$1.19 million released initially. The grant will serve approximately 900 of the 2,108 workers affected statewide by automotive layoffs resulting from the closures of Chrysler, LLC, located in Newark, Delaware, and General Motors Corporation, located in Wilmington, Delaware. The Vice President's Office will be notified when a decision is made.

During the week of July 27, the Employment and Training Administration (ETA) is expected to notify Delaware of the approval of its full share of the \$7 billion Unemployment Insurance (UI) Modernization special distribution.

ETA's Division of Youth Services will host a grantee orientation for the newly awarded YouthBuild grantees on July 28-30. The training will offer intensive training around key start-up issues for the successful implementation of a YouthBuild program including: program structure and design, meeting Departmental requirements, financial management, review of data management systems, and new recipient reporting requirements under the Recovery Act.

ETA staff is scheduled to participate in a review of California's Appeals system to analyze the effect of UI claims under the Emergency Unemployment Compensation 2008 program on the Appeals system.

ETA continues to finalize the release of several Recovery Act-related Training and Employment Guidance Letters (TEGLs) including those regarding: Recipient Reporting Requirements under Section 1512 of the Recovery Act; Use of Health Coverage Tax Credit Funds Made Available by the Recovery Act; Information and Guidance on the Two New Work Opportunity Tax Credit (WOTC) Targeted Groups Introduced by the Recovery Act; TEGL 22-08, Change 1, on the Trade Adjustment Assistance (TAA) Operating Instructions, including a series of Questions and Answers; Guidance to designate certifying officers to carry out functions under the TAA program; and Reporting Guidance and Instructions for the Workforce Investment Act, Section 166, Indian and Native American Supplemental Youth Service Program including performance accountability reporting for the Recovery Act.
