## Financial and Activity Report (sheet 2 of 2)

### Major Completed Actions (Short bulleted list of the major actions taken to date.)

As of August 28, 2009, \$2.4 billion has been distributed to a total of 30 states for UI Modernization incentive payments.

Secretary of Labor Hilda L. Solis announced that Illinois was approved for its share of the \$7 billion Unemployment Insurance (UI) Modernization special distribution. ETA notified the Department of Treasury to transfer the UI Modernization funds of about \$201 million into the Illinois State Account.

New Hampshire was also approved for its share of the \$7 billion Unemployment Insurance (UI) Modernization special distribution. ETA notified the Department of Treasury to transfer the UI Modernization funds of about \$21 million into the New Hampshire State Account.

New Mexico triggered “on” to Extended Benefits based on its Total Unemployment Rate. Beginning September 6, 2009, eligible claimants will be able to collect up to an additional 13 weeks of benefits.

Idaho triggered “on” to a High Unemployment Period within the Extended Benefits program. Beginning September 6, 2000, eligible claimants will be able to collect up to an additional 20 weeks of benefits.

An ETA official from the Office of Apprenticeship is serving on panel reviews scheduled for September 1-4, 2009, for the General Services Administration’s (GSA) Request for Proposals (RFP) on Pre-Apprenticeship Training announced last month. The RFP will award Recovery Act funds to GSA contractors to provide pre-apprenticeship training as part of the agency’s effort to renovate and upgrade Federal building. DOL and GSA signed a Memoranda of Understanding last June that establishes a collaborative relationship between both agencies to facilitate the establishment of certified pre-apprenticeship and registered apprenticeship programs in accordance with Recovery Act provisions.

On September 1, 2009, ETA released Training and Employment Guidance Letter (TEGL) No. 3-09, “Information and Guidance on the Two New Work Opportunity Tax Credit (WOTC) Targeted Groups Introduced by the American Recovery and Reinvestment Act of 2009.” The purpose of TEGL is to inform the State Workforce Agencies of two new WOTC targeted groups, unemployed veterans and disconnected youth, and to provide guidance for the effective and timely implementation of eligibility certification for these new groups.

ETA continues to process more than 1,600 petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009, that remain to be determined. Over 640 determinations have been made on cases filed under the new law.

ETA has undertaken an outreach strategy to recruit panelists to review Recovery Act grant applications. A letter from Assistant Secretary Jane Oates was sent to her federal counterparts at Environmental Protection Agency, National Science Foundation, the Small Business Administration, and the Departments of Agriculture, Commerce, Education, Energy, Health and Human Services, and Housing and Urban Development to request panelists for grant review. A notice is also posted on the ETA grants website.

**Employee Benefits Security Administration (EBSA)**

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been almost 127,000 since the enactment of the ARRA.

EBSA now has over 40,000 subscribers to [www.dol.gov/cobra](http://www.dol.gov/cobra) who will receive automatic notices of new or updated COBRA announcements with over 1,600,000 total visitors since enactment of the ARRA.

EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 8,600.

**Employment Standards Administration (ESA)**

Weatherization rates for all 50 states and the District of Columbia have been published and are posted on the ARRA web site.

**Office of Recovery for Auto Communities and Workers**

On Wednesday, September 2, 2009 Ed Montgomery, Director of the Office of Recovery for Auto Communities and Workers traveled to Saginaw, MI to participate in the Clean Energy Economy Forum with Governors Granholm and Doyle, Secretary Locke and DOE Assistant Secretary David Sandalow. After the meeting, together with David Sandalow he met with executives from Dow Chemical on the role they can play in Michigan's recovery.

**Office of the Inspector General (OIG)**

On September 2, 2009, OIG held an entrance conference with ETA to initiate work on an audit of YouthBuild grants awarded under ARRA, which provided \$50 million for YouthBuild activities. The audit objective is to determine if the grant solicitation and grant agreements complied with ARRA requirements. YouthBuild helps low-income young people ages 16–24 work toward their GED or high school diploma while learning job skills by building affordable housing for homeless and low-income people.



**Major Planned Actions (Short bulleted list of the major planned actions)**

ETA is expected to notify Colorado and West Virginia of the final decision regarding their 1/3 shares of UI Modernization incentive payments by September 9 and September 11, 2009, respectively.

ETA is compiling a weekly report, entitled the *Summer Youth Snapshot*, which provides highlights of Recovery Act-funded activities specific to the Summer Youth Employment Program from various program locations across the nation. Summer Youth Employment Program site visits, monitoring, technical assistance and training efforts conducted by ETA Regional Office representatives are ongoing through the end of September 2009.

ETA continues to finalize the release of several Recovery Act-related Training and Employment Guidance Letters (TEGLs): Implementing the Revised 2010 Trade Adjustment Assistance Trade Activity Participant Report (TAPR); Use of Health Coverage Tax Credit Funds Made Available by the Recovery Act; Information and Guidance on the Two New Work Opportunity Tax Credit Targeted Groups Introduced by the Recovery Act; TEGL No. 22-08, Change 1, on the Trade Adjustment Assistance Operating Instructions, including a series of Questions and Answers; Reporting Guidance and Instructions for the Workforce Investment Act, Section 166, Indian and Native American Supplemental Youth Service Program including performance accountability reporting for the Recovery Act; and TEGL No. 1-09, Change 1, Reporting Requirements under Section 1512 of the American Recovery and Reinvestment Act of 2009.
