

Employment and Training Administration (ETA)

Maine's three-month average seasonally-adjusted Total Unemployment Rate has dropped below the 8.5% threshold for the fourth tier of EUC. As a result, Maine will "trigger" off of the newly-created fourth tier of EUC, as of December 12, 2009.

On November 23, ETA issued Training and Employment Guidance Letter (TEGL) 22-08, Change 1, *Operating Instructions for Implementing the Amendments to the Trade Act of 1974 Enacted by the Trade and Globalization Adjustment Assistance Act of 2009*. Change 1 clarifies Trade Readjustment Allowances and Reemployment Trade Adjustment Assistance issues and helps states with the planning and programming needed to finalize the implementation of changes under the 2009 Amendments.

ETA continues to work towards making determinations for petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. As of November 27, 1,589 determinations have been made on cases filed under the new law.

On November 24, the U.S. Department of Labor awarded a Recovery Act funded National Emergency Grant for \$741,502 to assist approximately 164 workers affected by layoffs at 15 companies in multiple industries in the Oregon counties of Jackson and Josephine. The project will emphasize post-secondary education and training that allow workers to acquire the skills needed to enter careers in promising regional industries. The program provider will seek to offer opportunities for training in green industries, as well as other nationally-defined demand occupations.

ETA continues to respond to comments received in response to the Notice for Proposed Rulemaking (NPRM) on *TAA Merit Staffing of State Administration and Allocation of Training Funds to States*. In accordance with the TAA amendments mandated as part of the Recovery Act, the NPRM proposes regulations addressing how the Department distributes TAA training funds to the States that administer the program. The notice also proposes that personnel engaged in TAA-funded functions undertaken to carry out the worker adjustment assistance provisions must be State employees covered by the merit system of personnel administration, applicable to personnel engaged in employment security administration.

Employee Benefits Security Administration (EBSA)

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been almost 156,500 since the enactment of the ARRA.

Major Planned Actions (Short bulleted list of the major planned actions)

ETA staff is scheduled to conduct oversight reviews of the Emergency Unemployment Compensation (EUC) program in New Jersey and the Virgin Islands early December.

Monthly program Workforce Investment Act participation data for October 2009, which includes Recovery Act participants, is being reviewed and validated this week. The October 2009 data will be published on November 30, 2009.

ETA continues to finalize the release of several Recovery Act-related advisories: UIPL No. 14-09, Change 3, Special Transfers for Unemployment Compensation Modernization and Administration and Relief from Interest on Advances; TEN on Intent to Change Reporting Requirements for the Workforce Investment Act Standardized Record Data; and TEGL on the Use of Health Coverage Tax Credit Funds Made Available by the Recovery Act (National Emergency Grant policy guidance).
