Employment and Training Administration (ETA)

Last week, it was incorrectly reported that based on the Bureau of Labor Statistics' release of state Total Unemployment Rates (TURs), Maine would trigger "off" the Fourth Tier of EUC in mid-December. The triggers that control access to the new Third and Fourth Tiers of EUC, while using different Insured Unemployment Rate (IUR) and Total Unemployment Rate (TUR) levels than the EB triggers, are otherwise subject to the EB requirements, including the mandatory 13 week "on" and "off" periods. Since the newest EUC expansion created Tiers Three and Four as of the week beginning November 8, all states that met the trigger criteria for Tier Three or Four began a minimum 13-week "on" period on that date. Therefore, all states that were "on" when the program began will continue to be "on" through the week ending February 6, 2010.

ETA has published the October Workforce Investment Act data summary report on Recovery Act participants. National Emergency Grants served 4,873 individuals in October and 5,179 total to date. The number of youth who participated in a summer work experience was 314,732. This number may go up slightly due to adjustments by states, but can be considered the total number for summer 2009, exceeding the goal of 250,000-300,000. Wagner-Peyser Reemployment Services served 721,097 individuals in October for a total of 2,347,746 individuals served to date.

ETA released Unemployment Insurance Program Letter (UIPL) No. 14-09, Change 3, Special Transfers for Unemployment Compensation Modernization and Administration and Relief from Interest on Advances, on November 30.

ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. As of December 4, 1,675 determinations had been made on cases filed under the new law.

On December 1, the U.S. Department of Labor announced a Recovery Act funded National Emergency Grant (NEG) for \$2,422,000 to provide an estimated 1,892 jobless workers in Maryland, Alabama, Mississippi, and South Carolina with partial premium payments for health insurance coverage. This assistance allows individuals eligible for the Health Care Tax Credit (HCTC) to receive advanced, "gap-filler" payments of up to 80% of their qualified health insurance premiums.

The Recovering America's Youth Summit was convened in Dallas, TX on December 1-2 to share the findings and lessons learned from the 2009 summer youth employment program funded by the Recovery Act and to build capacity for serving older out-of-school youth in year-round activities.

Major Planned Actions (Short bulleted list of the major planned actions)

During the week of December 7, ETA staff will conduct oversight reviews of the following: Emergency Unemployment Compensation (EUC) and the Federal Additional Compensation (FAC) programs in Kansas; EUC, FAC, and Emergency Benefits (EB) programs in New Jersey; and EB and EUC programs in the Virgin Islands.

ETA is planning a series of webinars to provide broad workforce system training on the 2009 Amendments to the Recovery Act. Five webinars are planned to cover new reporting requirements, new training requirements, changes to Trade income support, the new Trade income supplement program and the Health Coverage Tax Credit. The first webinar is planned for December, and will focus on the new reporting requirements. The remainder of the webinars will follow early in 2010.

ETA is hosting a Recovery Act Performance Accountability Forum on December 9-10 in San Francisco, CA, building on the Performance Accountability Forum held in Baltimore, MD, last June. The Forum will provide technical assistance to participants from across the country as they plan, implement, and operate successful systems that support national priorities, comply with the Workforce Investment Act and the Recovery Act, and adhere to fiscal and programmatic requirements.

ETA continues to finalize the release of two Recovery Act-related advisories: TEN on Intent to Change Reporting Requirements for the Workforce Investment Act Standardized Record Data; and TEGl on the Use of Health Coverage Tax Credit Funds Made Available by the Recovery Act (National Emergency Grant policy guidance).
