Employment and Training Administration (ETA)

With the release of the November state Total Unemployment Rate (TUR) by the Bureau of Labor Statistics on December 18, 2009, three states (AK, CT, and DE) have met or exceeded the 8.5% TUR threshold to begin paying benefits in the Fourth Tier of Emergency Unemployment Compensation (EUC). The payable period in the Fourth Tier for these three states will begin on January 3, 2010. Wisconsin has dropped below the 8.5% TUR threshold with the latest data. Maine will end its payable period for the Fourth Tier of EUC on January 3, 2010 and Wisconsin will end its payable period for the Fourth Tier of EUC on January 9, 2010.

ETA conducted a webinar for grantees in advance of the next Recovery Act Section 1512 recipient reporting period beginning January 1, 2010. The webinar focused on OMB's updated guidance on job creation measurement, enhancements to the FederalReporting.gov reporting portal, and other technical assistance issues.

On December 23, ETA issued Unemployment Insurance Program Letter (UIPL) No. 4-10: *Extension of Temporary Provisions - Emergency Unemployment Compensation 2008, Federal Additional Compensation, and Extended Benefits*, to address the extension of Emergency Unemployment Compensation 2008 (EUC08), Federal Additional Compensation (FAC) and 100 percent funding of Extended Benefits.

ETA continues to make determinations for petitions submitted since the 2009 Trade Adjustment Assistance (TAA) amendments mandated in the Recovery Act took effect on May 18, 2009. As of December 24, 1,902 determinations have been made on cases received under the 2009 Amendments.

On December 23, 2009, ETA issued State Award Notifications for the Green Capacity Building and State Labor Market Information Improvement Grants to designated Points of Contacts in each state, per the Office of Management and Budget (OMB) guidance related on Recovery Act implementation. The state notifications help state governments keep track of Recovery Act-funded grants awarded in their state.

Employee Benefits Security Administration (EBSA)

EBSA continues to respond to hundreds of COBRA inquiries on a daily basis. There have been over 165,500 since the enactment of the ARRA.

EBSA now has over 49,500 subscribers to www.dol.gov/cobra who will receive automatic notices of new or updated COBRA announcements with over 2,085,000 total visitors since enactment of the ARRA.

EBSA continues to receive applications for expedited review of COBRA premium subsidy denials bringing the cumulative total to 13,261.
